WHO SHOULD INVEST


Investors seeking a hedge against any rand depreciation while gaining exposure to high yielding offshore assets that are not available locally in South Africa. Although this is a roll-up fund and does not distribute income, it is suitable to investors with a medium to long-term investment horizon who wishes to fund income withdrawals by redeeming units, due to the exposure to yield generating assets held in the Fund and therefore a lower probability of selling underlying units at inappropriate times such as in a market downturn.


RISK INDICATOR DEFINITION

RISK INDICATOR









FUND COMMENTARY

On the global macro front, recent communication from Federal Open Market Committee (FOMC) participants acknowledged substantial advancements toward the committee's two percent inflation target over the past year, notwithstanding firmer-than-expected inflation readings in recent months. While some participants highlighted the broad-based nature of these inflationary increases, caution was expressed regarding the potential influence of residual seasonality on early-year inflation data. Overall, participants reiterated their vigilance toward inflationary risks while anticipating some irregularities in monthly inflation indicators during the process of inflation returning to target levels. Participants assessed economic growth to decelerate from the robust pace observed in the previous year. This has seen market pricing a somewhat more dovish roadmap for US rates for the year.

With the elevated nature of the front end of developed market yield curves. The Fund is focusing on the very front end of the US curve. Specifically, 3-month deposits and floating rate instruments.

We see the Fund being favorably positioned given the attractive yield built into the Fund due to the risk focused signature we have maintained. With global yields remaining elevated, we are taking advantage of this.

Contributors to Performance:

The Fund performed slightly behind its benchmark for April, but pleasingly still saw a positive return for the month. Positive contributors were the shorter-term deposits as well as the floating rate instruments.

Detractors from performance:

The duration component detracted as yields moved higher with the good yielding assets benefitting the Fund.

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Average Duration: The weighted average duration of all the underlying interest bearing instruments in the Fund.

Forward Yield: The Forward Yield is the expected combined income of the instruments in the portfolio over the next year expressed as a percentage of the current value of those instruments.

Fund Specific Risks

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
