MINIMUM DISCLOSURE DOCUMENT

INVESTMENT AND RETURN OBJECTIVE

The Fund aims to return STeFi Call + 3% per annum through a full interest rate cycle by offering investors an enhanced income yield without undue risk on capital by maintaining constrained credit risk exposure.

INVESTMENT PROCESS

The Fund invests in a diversified portfolio consisting primarily of South African vanilla debt, mezzanine and structured instruments across the term structure and credit rating bands. Portfolio risk is managed at both single issuer and portfolio level. The former is done through an inhouse dynamic probability of default (PD) based rating model and the latter is through measuring the Expected Loss (EL), Loss Given Default (LGD) and credit VaR (Value at Risk). The Fund's modified duration will typically be below two years. Credit asset selection is underpinned by minimising default risk and credit spread duration.

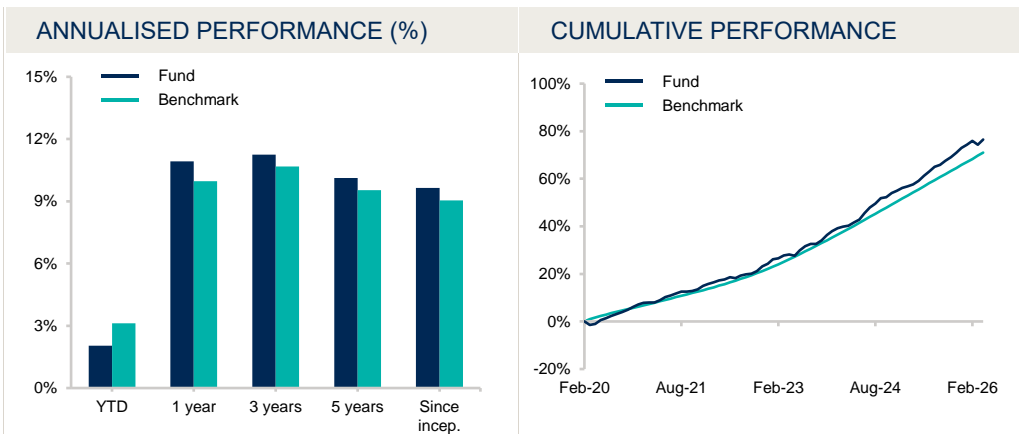
WHO SHOULD INVEST

Investors seeking performance in excess of what is available in the money market or a typical income fund. The Fund is Regulation 28 compliant.

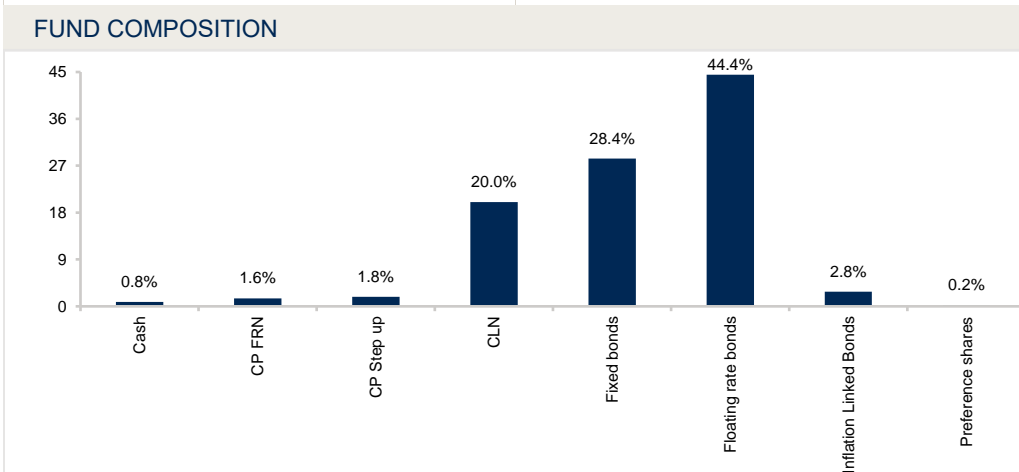
RISK INDICATOR DEFINITION

This portfolio typically has longer dated and complex credit exposures, resulting in some capital volatility and liquidity constraints to investors over the shorter term. It is managed in such a manner that the probability of capital losses over one-year periods is unlikely, and in a manner that would cater for client redemptions appropriately.

FUND COMMENTARY

On the global front, the Middle East conflict has disrupted the global disinflation narrative, introducing stagflationary risks alongside an already fragile growth outlook. Global growth is forecast at just above 3.0% for 2026, with risks skewed to the downside.

Locally, March CPI printed at 3.1% year-on-year, from 3.0% in February, with core inflation rising to 3.2% year-on-year. The data confirmed a relatively benign inflation backdrop ahead of the fuel shock triggered by the Middle East conflict, with rate decisions likely to remain highly dependent on the trajectory of oil prices and the rand.

Debt Capital Market (DCM) activity moderated in April, with R17.5bn of issuance, below the elevated R24.9bn recorded in March (April 2025: R11.4bn). Notably, 1 May 2026 marked the effective start of the "no new JIBAR" milestone, with the industry no longer permitted to issue new JIBAR-linked instruments. Floating-rate issuance is expected to reference ZARONIA going forward. Notable issuance from the banking sector includes Nedbank Group Ltd raising R2.7bn in Additional Tier 1 paper and Standard Bank Group Ltd raising R2.1bn in Tier 2 paper. The insurance sector was particularly active, with Sanlam Life Insurance Ltd raising R2.4bn and Old Mutual Life Assurance Company SA Ltd raising R1.8bn, both in subordinated debt. The REIT sector also saw meaningful supply, with Fortress Real Estate Investments Ltd raising R1.6bn, and Attacq Treasury Ltd raising R1.0bn. Year-to-date term issuance stands at R59.2bn, compared to R36.9bn over the same period last year.

Regarding our view on credit markets, our theme is determined by a combination of the output of our Credit Cycle Indicator (CCI), consideration of individual counterparty default probabilities, and the yields offered on these opportunities. Our CCI suggests continued heightened risk levels inherent in the South African Credit market, and the Fund's positioning emphasizes holding assets with defensive characteristics, while opportunistically taking on additional risk as deemed appropriate.

The Fund delivered a net return of 126 basis points over the month, against the benchmark return of 77 basis points. As at month-end, the Fund's gross yield was 10.35%, with a modified duration of 1.58 and a weighted term to maturity of 6.0 years.

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Average Duration: The weighted average duration of all the underlying interest bearing instruments in the Fund.

Forward Yield: The Forward Yield is the expected combined income of the instruments in the portfolio over the next year expressed as a percentage of the current value of those instruments.

Fund Specific Risks

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

Derivatives risk: The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.

Interest rate risk: The value of fixed income investments (e.g. bonds) tends to be inversely related to interest and inflation rates. Hence their value decreases when interest rates and/or inflation rises.
