INVESTMENT AND RETURN OBJECTIVE

The Fund offers efficient and cost effective exposure to listed property as represented by the FTSE/JSE SA Listed Property Index. Tracking error to the index is minimised in the process.

INVESTMENT PROCESS

The Fund is a property index fund where returns are enhanced by taking advantage of low risk arbitrage opportunities in the market. Additional benefits are gained from efficient implementation of cash flows, dividend reinvestments, management of corporate actions and index rebalancing. The Fund aims to remain fully invested in property shares at all times.

WHO SHOULD INVEST

Investors who require exposure to SA listed property shares and who are comfortable with the volatility and potential short term capital losses that can result from exposure to property shares.

RISK INDICATOR DEFINITION

These portfolios typically hold meaningful equity and/or offshore exposure which may result in significant capital volatility over all periods. Due to their nature expected long term returns are higher than for the other risk categories.

FUND COMMENTARY

Global equity markets ended 2025 on a definitive note, capping a year that consistently defied investor caution and underscored the resilience of risk assets. In December, the MSCI World Index rose 0.81%, bringing fourth-quarter gains to 3.12% and full-year returns to a robust 20.74%. Emerging markets outperformed into year-end, with the MSCI EM Index advancing 2.99% in December and delivering a standout 33.21% return for the year, supported by improving earnings momentum, a weaker US dollar and renewed risk appetite.

US equities were broadly flat in December despite supportive macro conditions and strong underlying fundamentals. The S&P 500 edged up just 0.06% for the month, closing the quarter 2.65% higher and ending 2025 with a 17.39% gain. While artificial intelligence remained the dominant structural theme, market leadership narrowed meaningfully as investors became increasingly selective within mega-cap technology. Defensive and value-oriented segments gained relative traction into year-end, reflecting elevated valuations and a degree of caution around growth sustainability.

European equities closed the year strongly, benefiting from currency tailwinds, improving sentiment and expectations of fiscal expansion. The Eurostoxx Index surged 3.63% in December and rose 5.04% over the quarter, delivering an exceptional 41.01% return for 2025. While local-currency returns were more modest, euro appreciation against the US dollar significantly enhanced outcomes for global investors. Financials and cyclicals were notable contributors, supported by stabilising inflation and the prospect of easing monetary policy in 2026.

In Asia, performance was mixed but broadly positive over the quarter. Japan's Nikkei 225 rose marginally in December but gained 5.87% over the quarter and 26.84% for the year, supported by reflation expectations and corporate reform momentum, despite bouts of yen volatility. Chinese equities rebounded into year-end, with the CSI 300 advancing 3.55% in December, as liquidity support and progress in domestic AI capabilities helped offset ongoing property-sector headwinds. Elsewhere in emerging Asia, returns remained uneven, reflecting profit-taking after a strong year and sensitivity to global semiconductor trends.

Sector performance during December and across the quarter highlighted the breadth of the 2025 rally. Financials and basic materials outperformed meaningfully, supported by improving credit conditions, strong commodity dynamics and robust precious metals performance. Technology delivered positive returns for the year but lagged in the fourth quarter, as elevated expectations and valuation concerns tempered further upside.

South African listed property delivered a strong finish to 2025, reflecting a material improvement in sector fundamentals and investor sentiment. While the sector was broadly flat in December, it gained 16.27% over the fourth quarter and delivered a robust 30.36% return for the year. Performance was supported by declining long-term bond yields, improving balance-sheet health and growing confidence that the worst of the interest-rate cycle is behind the sector. Continued progress on operational efficiency, stabilising distributions and selective asset disposals further reinforced the recovery narrative, positioning listed property as an attractive income-oriented allocation as markets look ahead to 2026.

The top contributors to the Fund's performance for the month were Vukile Property Fund Ltd (5.05%), Fairvest Ltd (11.03%) and Redefine Properties Ltd (2.56%). Detractors included Fortress Real Estate Investments (-7.22%), Growthpoint Properties Ltd (-1.94%) and NEPI Rockcastle NV (-0.50%).

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Dividend Yield: The weighted average dividend yield of all the underlying equity in the Fund. The dividend yield of each company is the dividends per share divided by the price.

PE Ratio: The weighted average price earnings ratio of all the underlying equity in the Fund. The price earnings ratio of each company is the price divided by the earnings per share.
