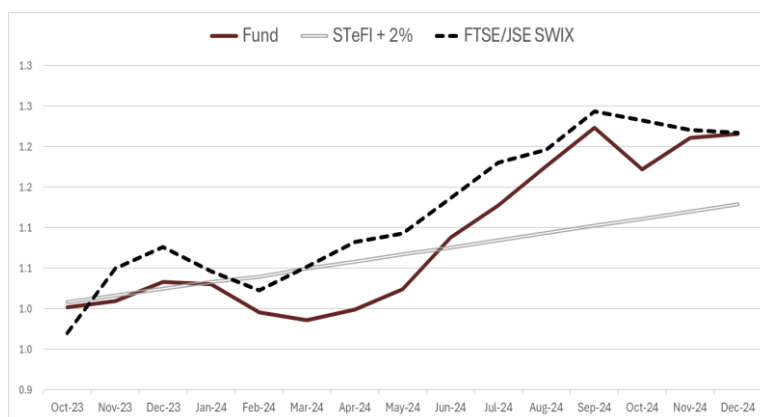
Risk Profile

MANAGER COMMENTARY

December 2024 was dominated by the rising benchmark 10-year yields across advanced economies. This was due to the various central banks giving hawkish commentary after their meetings, even after announcing a cut to the policy rates. The hawkish commentary highlighted the continued strong economic data, particularly from the US, and inflation staying stubbornly high. This caused the market to reduce the expectations of interest rate cuts in 2025 and this had a negative impact on risk assets.

The overall South African market traded slightly lower, with the Capped SWIX and the ALSI both declining by 0.3%. The FINI15 and RESI10 traded lower by 1.4% and 5.9% respectively, while the INDI25 increased by 2.5%. The strong performance from the INDI25 was driven by a strong performance by Naspers and Prosus after reporting consensus beating results. For the year, the Capped SWIX and ALSI returned 13.1%. Both the FINI15 (21.6%) and the INDI25 (17.3%) delivered strong returns for the year, while the RESI10 (-7.2%) experienced another tough year. The ALBI lost 0.3% in the month, but still performed strongly in 2024 returning 17.2%.

The fund was conservatively positioned in this difficult environment and outperformed the market in the month, providing investors with a positive return. This was mainly due to our lack of exposure to the resource sector. The Beta strategy, aimed at capturing market rallies, and the Alpha strategy, aimed at delivering uncorrelated returns based relative value positions, performed very well in the month contributing positively to the overall performance. Our Vega strategy, designed to protect capital during periods of heightened volatility, experienced a flattish month as the market struggled to accurately price volatility. The fund's exposure to offshore bonds also contributed to the outperformance as the ZAR depreciated. For the year, the Beta and Alpha strategies contributed healthily to performance, while the Vega strategy's performance was flat.

Looking ahead, we anticipate continued market volatility as investors grapple with the implications of high US equity valuations, rising global yields, and persistent inflation. We remain committed to leveraging our proprietary machine learning models to identify and capitalize on emerging opportunities while diligently managing risk. Our systematic, data-driven approach allows us to navigate these complexities and deliver superior risk-adjusted returns for our investors.

GLOSSARY

Annualised performance	Annualised performance shows longer term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.
Highest and Lowest return	The highest and lowest returns for any 1 year over the period since inception have been shown.
Max Drawdown	The maximum loss from a peak to a trough before a new peak is attained. Maximum Drawdown (MDD) is an indicator of downside risk over a specified time period
Moderate-Aggressive/ Medium-High	Generally, these portfolios hold more equity exposure than lower risk profiled portfolios. These portfolios therefore tend to carry more volatility. Expected potential long-term returns could be higher than other risk profiles, in turn potential losses of capital could be higher.
NAV	The net asset value represents the assets of a Fund less its liabilities.
Performance fee	The fund charges a performance fee of 20% of the amount by which it outperforms the hurdle rate, STeFI. The performance fee is payable quarterly in arrears. A high-water mark principle is applied in the performance fee calculation.
Sharpe Ratio	A measure of risk-adjusted performance. Calculated by dividing the annualized excess returns over the risk-free rate by Std Dev.
Standard Deviation (Std Dev)	A measurement of dispersion of a dataset relative to its average. When a fund has a high standard deviation, the predicted range of performance is wide, implying greater volatility.
Total expense ratio (TER)	TER reflects the percentage of the average Net Asset Value (NAV) of the portfolio that was incurred as charges, levies and fees related to the management of the portfolio. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER cannot be regarded as an indication of future TER's.
Total investment charge (TIC)	The sum of the TER and transaction costs is shown as the Total Investment Charge. Since Fund returns are quoted after the deduction of these expenses, the TER and Transaction costs should not be deducted again from published returns.
Transaction costs (TC)	TC is the percentage of the value of the portfolio that was incurred as costs relating to the buying and selling of the assets underlying the portfolio. Transaction costs are a necessary cost in administering the Fund and impacts returns. It should not be considered in isolation as returns may be impacted by many other factors over time, including market returns, the type of financial product, the investment decisions of the investment manager and the TER.

FUND SPECIFIC RISK

Derivatives risk	The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.
Currency exchange risk	Changes in the relative values of individual currencies may adversely affect the value of investments and any related income.
Geographic / Sector risk	For investments primarily concentrated in specific countries, geographical regions and/or industry sectors, their resulting value may decrease whilst portfolios more broadly invested might grow.
Derivative counterparty risk	A counterparty to a derivative transaction may experience a breakdown in meeting its obligations thereby leading to financial loss.
Liquidity risk	If there are insufficient buyers or sellers of particular investments, the result may lead to delays in trading and being able to make settlements, and/or large fluctuations in value. This may lead to larger financial losses than expected.
Equity investment risk	Value of equities (e.g. shares) and equity-related investments may vary according to company profits and future prospects as well as more general market factors. In the event of a company default (e.g. bankruptcy), the owners of their equity rank last in terms of any financial payment from that company.
Capital Risk	The capital value of Shares of a fund may be affected by various risks to capital, including the potential risk of erosion due to the redemption of Shares and the distribution of profit in excess of the investment return. This risk can be limited by loss-mitigation, capital-protection or capital-guarantee techniques.
Leverage Risk	This means that the Fund borrows additional funds, or trades on margin, to amplify investment decisions. The degree to which leverage may be employed in any given hedge fund portfolio will be limited by the mandate the client has with the Fund.
