




FUND OBJECTIVE & STRATEGY

The investment objective of the Fund is to provide long term capital appreciation and income growth through investment in a concentrated portfolio of assets. The fund is primarily exposed to a focused portfolio of developed market equities. The fund is managed on the basis of the long term ownership of assets and has a bias towards high quality ideas. Investors with a time horizon of three to five years are ideally suited to this fund.

MONTHLY COMMENTARY

The ClucasGray Global Fund rose 1.4% in December and 1.9% in the fourth quarter, while the Morningstar Aggressive Allocation peer group gained 0.8% in the month and 2.7% in the quarter.

Global equities started the fourth quarter on a strong note, buoyed by better-than-expected corporate earnings and a thaw in US-China trade tensions, but lost momentum as the quarter progressed. Initial gains were concentrated in technology sectors, with particularly strong momentum in the AI trade, however, investors grew concerned about elevated valuations and the vast capital requirements to build out AI-related processing infrastructure, leading to a pullback in November. Markets then traded modestly higher to close out the year, with US equities trailing their European counterparts.

In December the US Federal Reserve reduced interest rates by 25 basis points as widely expected, however, there was some disagreement on the path of interest rates in the coming year. Some members expressed concern that entrenched inflation could require higher borrowing costs, while others favoured more aggressive rate cuts to counter signs of a softening labour market. US inflation readings have come in slightly below expectations in recent months but remain above the Fed's official target.

The Fund's top-performing holding in the fourth quarter was Alphabet (+28.8%). The company reported robust Q3 financial results, benefitted from a benign resolution to its US antitrust case and gained strong traction with its AI model, Gemini. The market's perception of the company has shifted from AI-loser to AI-winner, driving a sharp re-rating of the stock. Further strong contributions came from LVMH (+23.7%), which surprised the market with broad-based improvements in sales growth; and a rebound in Thermo Fisher (+19.5%) as regulatory tensions in its key pharmaceutical end-market eased. The largest detractors from Fund performance were AutoZone (-20.9%), where an earlier rally had pushed valuations well beyond the historical range, and Evolution AB following disappointing quarterly results.

During the quarter, the Fund initiated a new position in Relx, a UK based provider of information analytics and decision tools. The company holds leading market positions in proprietary databases and decision tools for the insurance, legal, scientific and medical end-markets.

At the end of December, the Fund had an underlying exposure to equities of 98.3%, and 1.7% cash.

The Fund has adhered to its investment policy.

The number of participatory units at 31 December 2025 was 408 525.






FUND ASSET ALLOCATION




NET CURRENCY EXPOSURE

Transaction costs are a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER.
