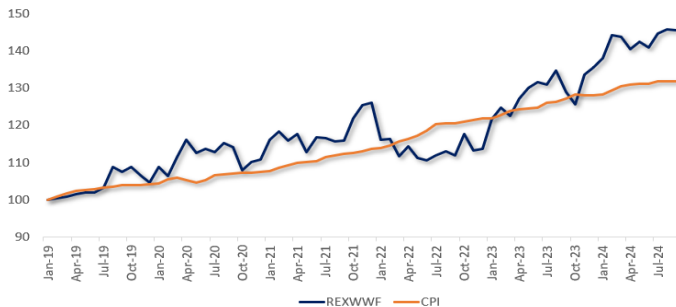

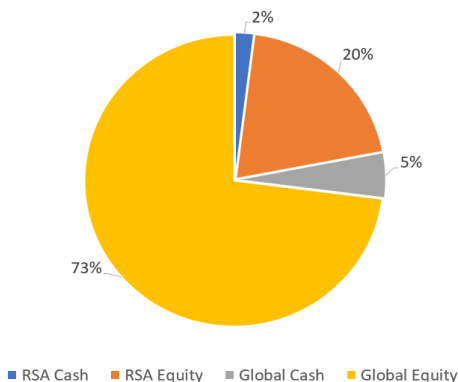

The Rexsolom Worldwide Flexible Fund ended the month -0.1% weaker but managed a quarterly return of 3.2% and a year return of 13% in ZAR terms. The USD/ZAR exchange rate has dramatically improved to R17.20 at the end of the month thus detracting from the fund's Rand return. In Dollar terms the fund ended the month 3.1% higher and 23.6% higher over the last year. The fund has now recorded a return of 17% p.a in USD over the last 2 years. Significant contributors during the month included Applovin, Tesla and AVI. The fund has a 22% allocation to South Africa which is aiding in returns as the market continues to price in the new GNU. During the month we added Discovery to the fund and introduced China exposure to the fund. We also upweighted LVMH, the luxury goods business. Both Hermès and LVMH (5.6% of the fund) reacted positively to the extra liquidity measures taken by the Chinese authorities.

During the phase in period TER's do not include information gathered over a full year. Transaction Costs (TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER. Where a current yield has been included for Funds that derive its income primarily from interest bearing income, the yield is a weighted average yield of all underlying interest bearing instruments as at the last day of the month. This yield is subject to change as market rates and underlying investments change.

The portfolio is permitted to invest in foreign assets. These may have additional risks associated with them such as country and exchange rate risk. Disclaimer for Fund specific risk

Default risk: The risk that the issuers of fixed income instruments (e.g. bonds) may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
