INVESTMENT PROCESS


This Fund invests in local and offshore money market, bonds and inflation-linked bonds, property, preference and ordinary shares, derivatives and unlisted instruments to meet the investment objectives. Fund performance can be generated from taking interest rate views or duration, yield enhancement via credit instruments, asset allocation and exposure equities.

WHO SHOULD INVEST

Investors seeking real returns coupled with a stable and attractive income yield via significant exposure to the South African interest bearing markets. Although the Fund's mandate allows investment up to 40% in equities, it is expected to have lower actual exposure on average. This Fund is suitable to investors with a medium to long-term investment horizon and is Regulation 28 compliant.

RISK INDICATOR DEFINITION

These portfolios typically have moderate equity exposure or in the case of bond funds, longer duration bond exposure, resulting in some capital volatility over the shorter term. They are managed in such a manner that the probability of capital losses over one year periods is unlikely. These portfolios typically target returns in the region of 3% - 4% above inflation over the long term.



FUND COMMENTARY

On the global stage, the United States imposed additional sanctions on Russia, intensifying pressure on Moscow in the final days of the Biden administration. Following Donald Trump's inauguration on January 20, he pledged to address inflation by declaring a national energy emergency aimed at reducing costs for Americans. His plans focus on boosting domestic production through policy changes that would enable new oil and gas development on federal lands, while also rolling back climate regulations introduced during the Biden administration. Trump has expressed opposition to climate change mitigation efforts, including withdrawing the U.S. from the Paris Climate Agreement and pledging to revoke the electric vehicle mandate. While Trump did not announce China-specific tariffs on his first day in office, he indicated that federal agencies would review policies related to levies on China.

While the Federal Reserve's independence remains a cornerstone of economic stability, the policy actions under Trump, combined with ongoing inflation risks, are creating a challenging environment for markets—particularly for bond investments and inflation hedges like gold. Although the Fed has signaled the potential for two rate cuts this year, it opted to keep rates steady at its first meeting of the year, as persistent inflation remains well above the central bank's 2% target. Economists suggest that Trump's economic policies, coupled with geopolitical uncertainties, could drive higher prices, potentially prompting the Fed to delay rate cuts for the remainder of the year or even consider raising rates to combat inflationary pressures.

The South African Reserve Bank (SARB) had anticipated a rate cut for January, and during its Monetary Policy Committee (MPC) meeting at the end of the month, it delivered a 25-basis point (bps) reduction, as expected. A further 25 bps decrease is projected for 2025, which would bring the repo rate to 7.25%. With inflation remaining below the SARB's target range of 3% to 6%, economists expect headline inflation to be 3.2% in January, rising to above 5% by the end of the year, driven by diminishing base effects and improving demand. The SARB also confirmed that it will host an inflation-targeting conference in March, potentially leading to a revision of its inflation target.

The final week of January saw Chinese company DeepSeek's artificial intelligence (AI) model make waves on Wall Street, causing significant declines in major tech stocks like Nvidia and sparking concerns about the future of America's dominance in AI. Despite these developments, Donald Trump views AI advancements as potentially beneficial for the U.S., suggesting that cheaper AI development could provide the same results at a lower cost, ultimately benefiting the country.

Despite these concerns, equity indices globally showed mostly positive performance for the month. The S&P 500 gained 2.78%, the tech-heavy Nasdaq increased by 1.64%, the UKX rose 6.13%, and the EuroStoxx50 was up 7.98%. However, some major indices posted losses, including the Shanghai SE Composite Index and the Nikkei 225, which saw declines of -3.02% and -0.81%, respectively. Meanwhile, the US Treasury Index gained 0.52%, likely driven by increased market uncertainty following Trump's return to office.

The FTSE/JSE All Share Index, helped by strong performances in the resources sector, posted a gain of 2.32%. The ALBI gained 0.44%, while the CILI fell 0.32%. The Rand strengthened against the dollar by 1.21% over the course of the month.

The Fund currently holds a moderately negative view towards developed equity markets, a neutral stance on South African bonds and emerging market equity, and a moderately positive outlook on Rand strength and South African equity.

The Fund was positive for the month, mainly due to strong performance in both local and overseas equity markets.

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Fund Specific Risks
