INVESTMENT AND RETURN OBJECTIVE

The Fund aims to deliver returns close to the MSCI Emerging Markets Index Total Return at low cost. Although the Fund is structured similarly to the MSCI Emerging Markets Index, it is not a tracker fund and can out / underperform the MSCI Emerging Markets Index by small amounts over time.

INVESTMENT PROCESS

The Fund follows an investment process which firstly endeavours to follow the composition of the MSCI Emerging Markets Index closely and secondly seeks enhancement opportunities to secure for investors an optimum overall return. The Fund can use derivatives to create exposure to the MSCI Emerging Markets Index or subsets thereof in a low cost and efficient manner.

WHO SHOULD INVEST

Investors who are seeking long term capital growth through diversified exposure to the global markets by investing in a fund with a low tracking error relative to the MSCI Emerging Markets Index and who are cost conscious.

RISK INDICATOR DEFINITION

These portfolios typically hold meaningful equity and/or offshore exposure which may result in significant capital volatility over all periods. Due to their nature expected long term returns are higher than for the other risk categories.

FUND COMMENTARY

Despite ending on a positive note, global equity markets were notably unsteady going into August. A dangerous mix of underwhelming earnings—particularly from the U.S. technology sector—combined with weak labor market data hinting at an economic slowdown, a major yen-funded carry trade unwind from Japan, and escalating geopolitical tensions in both the Middle East and Russia, sent a stunning shockwave throughout the markets. The MSCI World Index lost 6.40% in just the first three trading days of the month, while the VIX Index spiked over twenty points to reach levels last seen in 2020. The bears eventually calmed down as the month progressed, and regular programming resumed. Softer inflation numbers and dovish commentary once again provided the tailwind for firmer market performance. The MSCI World Index concluded the month up 2.64%, while the S&P 500 Index in the U.S. gained 2.43%. European markets, although still playing catch-up to their U.S. counterparts, were similarly strong, with the Eurostoxx posting a solid 3.74% gain. Local currency depreciation in Japan helped the Nikkei achieve a positive 1.77% return in U.S. dollars. Emerging markets were broadly firmer in August, although the MSCI EM Index posted a relatively modest 1.61% return, largely moderated by weakness in China, where the CSI 300 Index gave back 1.77%. The MSCI EM TR Net Index (USD) returned 1.61% for the month, bringing its year-to-date performance to 9.55%. The Fund was marginally behind the benchmark for the month, gaining 1.22% (gross of fees).

Contributors to Performance:

The positions that contributed most to the absolute performance of the Fund for the month were Tencent Holdings (5.47%), Alibaba Group Holding Ltd (+5.37%), Taiwan Semiconductor Manufacturing Co Ltd (+1,07%).

Detractors from Performance:

The largest detractors from the month's absolute performance were Samsung Electronics Co Ltd (-11.44%), PDD Holdings Inc (-25.43%) and SK Hynix Inc (-10.74%).

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Dividend Yield: The weighted average dividend yield of all the underlying equity in the Fund. The dividend yield of each company is the dividends per share divided by the price.

PE Ratio: The weighted average price earnings ratio of all the underlying equity in the Fund. The price earnings ratio of each company is the price divided by the earnings per share.

Fund Specific Risks

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

Derivatives risk: The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.

Interest rate risk: The value of fixed income investments (e.g. bonds) tends to be inversely related to interest and inflation rates. Hence their value decreases when interest rates and/or inflation rises.

% Property risk: Investments in real estate securities can carry the same risks as investing directly in real estate itself. Real estate prices move in response to a variety of factors, including local, regional and national economic and political conditions, interest rates and tax considerations.

Geographic / Sector risk: For investments primarily concentrated in specific countries, geographical regions and/or industry sectors, their resulting value may decrease whilst portfolios more broadly invested might grow.

Derivative counterparty risk: A counterparty to a derivative transaction may experience a breakdown in meeting its obligations thereby leading to financial loss.

Equity investment risk: Value of equities (e.g. shares) and equity-related investments may vary according to company profits and future prospects as well as more general market factors. Transaction Costs(TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction cost are a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER.

Where a current yield has been included for Funds that derive its income primarily from interest bearing income, the yield is a weighted average yield of all underlying interest bearing instruments as at the last day of the month. This yield is subject to change as market rates and underlying investments change.
