Investment Objective and Strategy

The Fund aims to achieve a total return in excess of SA inflation +5% per annum over the longer-term, while actively managing the risk attached to the portfolio.

The Fund will invest in a diversified mix of worldwide assets, including equities, bonds, property, cash, preference shares, collective investment schemes and other instruments as determined by the Authority from time to time that conform with the Fund objectives.

The Fund will be positioned according to the managers' assessment as to prevailing investment prospects of each asset class and existing, as well as potential, underlying assets. When deemed appropriate the Fund may invest in offshore assets up to a maximum of 100% of the portfolio.



These figures represent the highest and lowest rolling 12-month returns on each unit class of the Fund since inception.

Activity during the guarter

A quiet period in Q4 for the Fund as rotation, in line with our investment process, out of overvalued stocks had been taking place earlier in the year as markets rose strongly. Screening showed attractive valuations / stable distributions in energy stocks Exxon Mobil (XOM) and Petroleo Brasileiro (PBR), which were added judiciously during the period.

As expected from a stock and geographically diversified portfolio, the source of both contributors to and detractors from absolute returns was diverse. From policy uncertainty surrounding Chinese stocks (PDD), slowing Chinese growth (GLN) to political upheaval in South Korea (SHG). Contributors were just as diverse, from a resumption in travel (BKNG) to Japanese banks (SMFG), consumer (AMZN), tech (GOOGL) and cyber security (PANW).

Changes in asset allocation

With the portfolio appropriately positioned previously in the year in line with our investment process which favours an appropriate margin of safety, a wide and defensive moat and excellent capital deployment by management the increase in equity exposure is detailed above at the stock level. Portfolio cash is held primarily in USD, which has been particularly strong over the period as previous views on rate reductions are revisited.

A note on portfolio risk

Drawdown measures the peak-to-trough decline during a specific period, quoted as a percentage between the latest peak and subsequent trough of the Fund, before a new peak is achieved. It is instructive when measuring the loss to the portfolio during a period and the subsequent return required to return to the previous peak of the portfolio. The drawdown profile shown alongside depicts the increased volatility being experienced in risk markets over the past 5 years. Asset allocation intervention during such periods is necessary to compress the recovery time factor and/or limit further downside. The appropriate period over which to measure performance of the Fund is rolling 5-year periods, given the risk profile and recommended holding period. Shorter measurement periods are linked to a higher variance in returns (see table below left).

Adherence to Fund Policy Objective

The Fund has adhered to its Policy Objective, as stated in the Supplemental Deed, in all respects during the quarter. There are no unresolved breaches to report from prior periods.
