

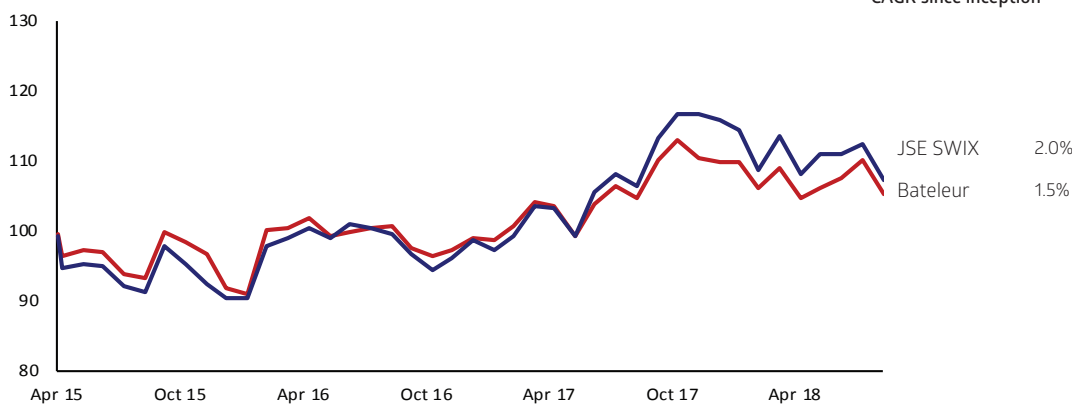
Investment objective

The Bateleur Equity Prescient Fund aims to generate returns in excess of the JSE Shareholder Weighted All Share Index over the medium to longer term, within acceptable risk parameters.

Strategy

The fund invests in listed equities on the JSE that the portfolio manager deems to be undervalued relative to the JSE Shareholder Weighted All Share Index (SWIX)

Collective Investment Schemes in Securities (CIS) should be considered as medium to long-term investments. Forward pricing is used. The Fund's Total Expense Ratio (TER) reflects the percentage of the average Net Asset Value (NAV) of the portfolio that was incurred as charges, levies and fees related to the management of the portfolio. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER cannot be regarded as an indication of future TER's. During the phase in period TER's do not include information gathered over a full year. Transaction Costs(TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER

Risk Guidance:

Low:

Generally low risk portfolios have minimal equity exposure or equity exposure, resulting in far less volatility than more aggressive mandated portfolio and in turn the probability of capital loss (permanent/temporary) is less likely
However, expected potential long term investment returns could be lower over the medium to long term

Moderate:

These portfolios generally hold more equity exposure than low risk portfolios but less than high risk portfolios.
In turn the expected volatility is higher than low risk portfolios but less than high risk portfolios
The probability of losses are higher than low risk portfolios, but less than high risk portfolios
Expected potential long term investment returns could therefore be lower than high risk portfolios due to lower equity exposure, but higher than low risk portfolios.

High:

Generally these portfolios hold more equity exposure than any other risk profiled portfolios, therefore tend to carry more volatility.
Expected potential long term returns could be higher than other risk profiles, in turn potential losses of capital could be higher.

Derivatives risk:

The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.

Currency exchange risk:

Changes in the relative values of individual currencies may adversely affect the value of investments and any related income.

Equity investment risk:
