MONTHLY COMMENTARY

The SA Listed Property Index (SAPY) and the All Property Index (ALPI) recorded total returns of -2.60% and -2.56% respectively for the month of September, with the historic yield of the SAPY ending the month at 9.0%. The yield-to-maturity (YTM) on the Long-Term South African government bond (RLRS) de-rated by 4 bps, ending the month at 9.22% (9.18% - 31 August 2018). During the month Stats SA announced that South Africa has entered a technical recession after two consecutive quarters of negative growth. On 20th September the SARB announced that the repo rate will remain unchanged in contrast to other emerging market countries which raised interest rates over the period (Russia, Turkey, Pakistan, Indonesia, India). The SARB decision had little respite for SA listed property returns which delivered negative returns (-2.6%) in line with the broader equity market (-4.2%) over the month.

Globally, the FTSE EPRA/NAREIT Developed Net Rental Index recorded a net total USD return of -2.37% in September. The best performing listed real estate market was Singapore, which recorded a total USD return of 0.85%. Europe ex-UK recorded the lowest total USD return for the month of -3.09%. The outlook for real estate returns in the face of expected interest rate increases is understandably a current focus point for many investors. Conventional wisdom and the narrative that is most commonly encountered is that rising interest rates is the Achilles heel that will bring about the end of the current real estate cycle.

The Fund's offshore allocation is approximately 54% on a see-through basis. Global real estate fundamentals remain healthy overall, mainly due to manageable supply levels relative to demand, with an improved economic growth outlook. Taking the estimated forward FAD (Funds Available for Distribution) yield of 4.89%, and medium-term growth prospects into account, global listed real estate currently looks fairly valued on a risk-adjusted basis. Despite the weak outlook for local property fundamentals and downward revisions to earnings, SA listed real estate remains attractively priced. We expect the SA listed sector to deliver 13% – 15% total return in ZAR driven by its core drivers being income yield and capital return from distribution growth.

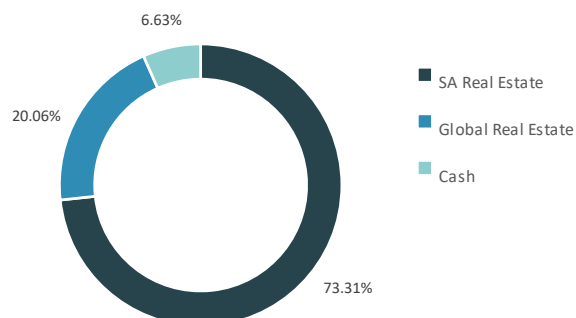

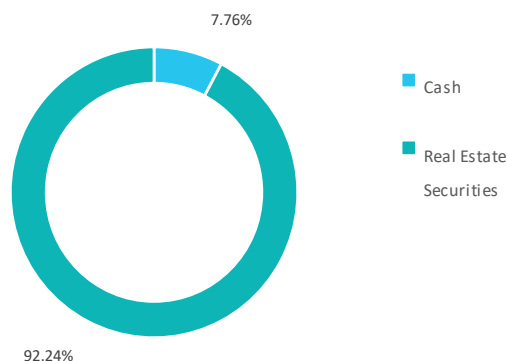
