MONTHLY COMMENTARY

The SA Listed Property Index (SAPY) and the All Property Index (ALPI) recorded total returns of -2.60% and -2.56% respectively for the month of September, with the historic yield of the SAPY ending the month at 9.0%. The yield-to-maturity (YTM) on the Long-Term South African government bond (RLRS) de-rated by 4 bps, ending the month at 9.22% (9.18% - 31 August 2018). During the month Stats SA announced that South Africa has entered a technical recession after two consecutive quarters of negative growth. Despite the negative economic data and the US Fed's 25bps rate hike, the rand strengthened by 3-4% against the US Dollar, British Pound and Euro during the month. On 20th September the SARB announced that the repo rate will remain unchanged in contrast to other emerging market countries which raised interest rates over the period (Russia, Turkey, Pakistan, Indonesia, India). The SARB decision had little respite for SA listed property returns which delivered negative returns (-2.6%) in line with the broader equity market (-4.2%) over the month.

Revision to growth expectations has continued unabated during the period as the weakening of domestic property fundamentals combined with the repercussions of distributing non-recurring unsustainable income in prior periods has become unavoidable. Despite the weak outlook for local property fundamentals and downward revisions to earnings, SA listed real estate remains attractively priced. On average, SA centric companies are trading at forward yields above the long-term South African Government Bond proxy (RLRS). Similarly, dual listed offshore companies are trading at attractive forward yields relative to their respective long-term government bond yields. We expect the sector to achieve inflationary growth in distribution per share over the long term.

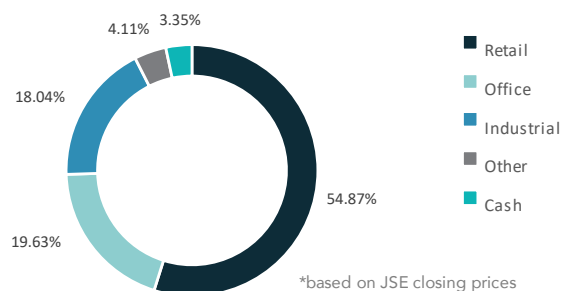

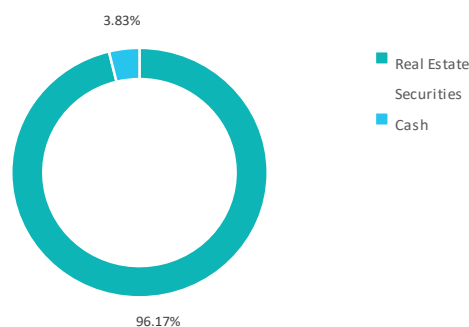
FUNDS SECTORAL ALLOCATIONS AS AT 30 SEPTEMBER 2018

SPECIFIC FUND RISK
