



Glossary

Annualised Performance

Annualised performance is the average return per year over the period.

Highest and Lowest 1-Year Rolling Return

Represents the highest and lowest return that the investor would have realised while being invested in the fund over any 12-month period since the fund inception date

NAV

The Net Asset Value (NAV) represents the value of the assets of a fund less its liabilities.

Risk Profile

A number on a scale of 1 to 7 on how much the value of a fund has fluctuated over the past 5 years (or an estimate if the fund has a shorter record). A rating of 1 represents the lower end of the risk scale with potentially lower rewards available whilst a rating of 7 reflects higher risk but potentially higher rewards.

Total Expense Ratio (TER) and Transaction Costs

The TER reflects the percentage of this Fund's Net Asset Value that was incurred as expenses relating to the administration of this Fund, including the annual fee and intermediary fee if applicable. A Higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER may not necessarily be an accurate indication of future TER's. Transaction costs are a necessary cost in administering this Fund and impacts this Fund's returns. Total Investment Charge

This is the sum of the TER and TC.
