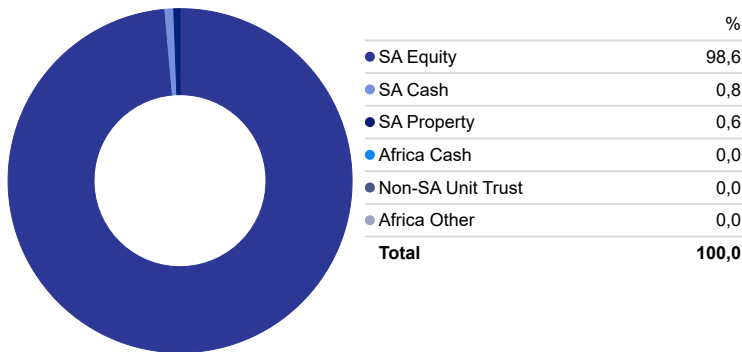
INVESTMENT OBJECTIVE

The fund is an actively managed South African general equity portfolio with a focus on maximizing total returns. The portfolio's objective is to offer medium to long-term capital growth. The portfolio will invest a minimum of 80% of its net asset value in South African equity securities, including listed shares on the Johannesburg Stock Exchange (JSE) and other approved South African exchanges. Up to 20% of the NAV may be allocated to money market instruments, cash, or other short-term investments during periods of elevated market volatility or when attractive investment opportunities are limited. The portfolio may invest across all sectors of the economy but will maintain diversification within sectors to mitigate concentration risk.

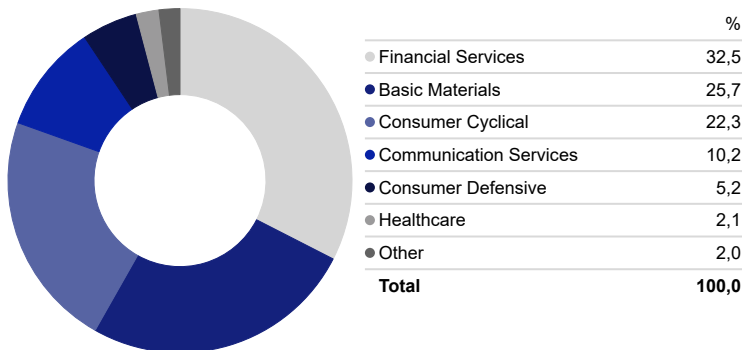
INVESTMENT POLICY

The portfolio has a long-term focus and invests in securities across all sectors of the JSE Securities Exchange which trade below their intrinsic value or have capital appreciation potential.

FUND COMMENTARY

The Interactive SA Equity Prescient Fund delivered an impressive 14.04% return for Q3 2025, extending its five-month gain to 22.38%, and significantly outperforming the ASISA South African Equity General benchmark (9.24%). The strong performance was driven by broad-based gains across the resources and financial sectors, aided by improved sentiment in domestic equities, moderating inflation expectations, and a stabilising rand.

Leadership came from gold and platinum counters, with Gold Fields (+77.0%), Valterra Platinum (+56.7%), AngloGold Ashanti (+56.5%), and Sibanye Stillwater (+52.8%) among the standout contributors as precious metals surged on rising expectations of global rate cuts and continued geopolitical uncertainty. Diversified miners such as Anglo American (+29.8%) and Glencore (+22.0%) also added materially to returns, reflecting renewed investor appetite for cyclical.

The fund further benefited from selective exposure to industrial and global growth names, including Prosus (+26.3%), Naspers (+13.4%), and British American Tobacco (+14.0%), which supported returns as global equity markets hit record highs. Within the domestic financial sector, Standard Bank (+7.5%) and Absa (+7.4%) delivered steady gains, underpinned by resilient credit quality and improved earnings guidance.

Detractors were largely concentrated in consumer and retail holdings, where Woolworths (-1.3%), Capitec (-2.2%), Life Healthcare (-2.4%), and Clicks (-4.4%) came under pressure amid cautious household spending and tight disposable income trends.

From a thematic perspective, the period was characterised by a rotation back into resource and high-beta equities, supported by global monetary easing expectations and stable commodity demand. The fund's disciplined quality and valuation approach - favouring companies with strong cash generation and sustainable competitive advantages - aims to underpin outperformance through both recovery and contraction phases.

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

FUND SPECIFIC RISK
