### Investment objective

The Maestro Equity Prescient Fund will be a general equity portfolio. The Manager in selecting securities for the portfolio will seek to follow an investment policy which will secure for investors an optimum overall return, which is to say the steady growth of income and the preservation of capital in real terms. In order to achieve these main objectives, the investments to be acquired for the Maestro Equity Prescient Fund, shall comprise a mix of securities, financially sound ordinary shares, stock, financially sound preference shares, debenture stock, debenture bonds and unsecured notes as defined in the Act and the Deed, all to be acquired at a fair market value.

### The Fund benchmark

The Fund will measure itself against the FTSE-JSE All Share Index.  
ASISA Classification: South African-Equity-General.

### Legal structure

The Fund is a scheme in the nature of a trust known as a collective investment scheme. The portfolio manager is Maestro Investment Management (Pty) Ltd, an approved Financial Services Provider in terms of the Financial Advisory and Intermediary Services Act, operating under license number 739. This portfolio operates as a white label fund under the Prescient unit Trust Scheme, which is governed by the Collective Investment Schemes Control Act.

### Fee structure

The maximum initial fee is 2.0%. The annual investment management fee is 1.75%. The annual total expense ratio (TER) for period ended 30 September 2025, in respect of class A was 2.61%.

## Market Overview

Markets began the year with their usual enthusiasm; after all, 2025 was a particularly profitable year for many global equity investors, with numerous market indices ending at, or close to, record levels. As usual though, there were a few hiccups around mid-month, which rattled investors. Certain corporate results were disappointing and of course there is a great deal of “noise” on the political front, more than sufficient to not only keep investors alert but also to frighten many away. The last few days of January were particularly unprofitable for tech investors, as questions surrounding the valuations of AI-related companies resurfaced.

When all was said and done though, markets all ended up on the month; the MSCI World index rose 2.2%, but it was emerging markets which really grabbed the limelight. They were ably supported by a weak dollar – it lost 1.4% on the month. Its weakness was an important driver of prices in the emerging equity and currency, and commodity markets. The MSCI Emerging Market index rose 8.8% in January alone, spurred higher by the Brazilian market, which rose 12.6%. The South African All Share index rose 7.2% in dollars, and the Turkish equity market rose 22.9%. The Chinese equity market rose 3.8%, the Hong Kong market rose 6.9% and the Japanese market 5.5%. The tech-heavy NASDAQ index rose a modest 1.0%, while the S&P Mid and Small cap indices led their larger cap counterparts higher, rising 4.0% and 5.6% respectively (remember the Large cap [S&P500] index rose 1.5%).

The Bloomberg Global Aggregated Bond index rose 0.9%, bringing its annual gain to 8.6% versus the MSCI World and Emerging Market indices’ respective annual gains of 18.0% and 39.8%.



The euro, Swiss franc, and sterling were all firm against the dollar, as was the rand, which rose 3.3% against the greenback. However, it was the commodity complex which usurped most of the limelight in January, with many metals continuing their scintillating 2025 run. Notwithstanding a sharp sell-off towards the end of the month, the price of gold rose 15.1%, platinum rose 8.6%, palladium 10.2% and silver 30.5%; the price of silver has risen 202.2% during the past year. The oil price rose 15.7% and copper 7.8%. These are extraordinary gains and come on the back of very firm prices during 2025.

**Local market returns**

Not surprisingly, the South African market was firm during January, continuing its formidable run of 2025. The All Share index rose 3.7%, bringing its annual gain to 44.4%. It was led by the Basic Materials index, which rose 11.1% in January. The Financial index rose 2.9% but the Industrial index lost 3.7%. The All Bond index rose 2.0%. The Large, Mid and Small cap indices rose 4.0%, 5.8%, and 1.4% respectively.

**Investment Manager comment**


The Maestro Equity Prescient Fund rose 2.2% in January, versus the 3.7% gain of the All Share index. The primary reason for the Fund’s under-performance its underweight exposure to gold shares and the basic material sector.

There were no material changes to the Fund’s portfolio, and the Fund adhered to its Policy objective during the month.




