RISK PROFILE

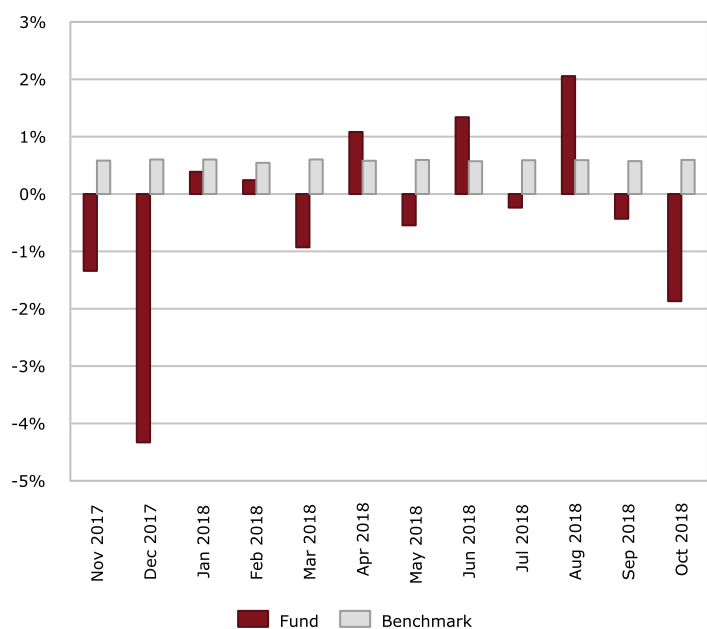


These portfolios generally have lower net equity exposure than long only equity portfolios over time. The portfolios are designed to have only some market directionality and in turn the expected volatility can be higher than a low risk portfolio but should be less than that of a long only portfolio. The underlying hedge funds are allowed to make use of short selling and leverage which could result in capital losses at some point. Expected potential long term investment returns could therefore be higher than low risk portfolios due to higher equity exposure.

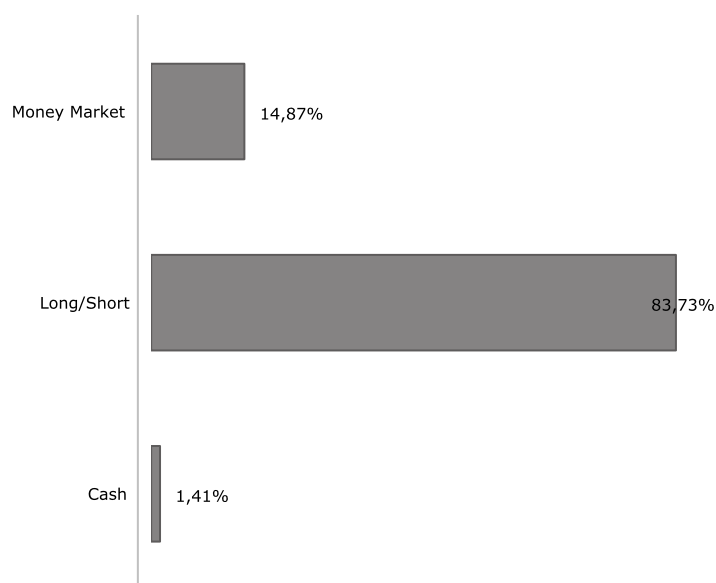
INVESTMENT OBJECTIVE AND SUMMARY

The 27Four Long Short Equity Prescient QI Fund of Hedge Funds is a blend of South African long short equity hedge funds that aims to deliver above average positive risk-adjusted returns, independent of market direction. The underlying funds will predominately be invested in equities, but has a flexible mandate allowing for some diversification into other asset classes, including but not limited to bonds, commodities, debentures, money market and property markets. The portfolio is permitted to invest in listed and unlisted financial instruments in line with the conditions as determined by legislation from time to time. The fund will employ a VAR approach to measure exposure.

GLOSSARY

Annualised Performance:	Annualised performance show longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.
Best Month:	Largest increase in any single month.
Highest & Lowest Return:	The highest and lowest returns over any 1 year period since the inception date.
Max Drawdown:	The maximum peak to trough loss suffered by the Fund since inception.
NAV:	The net asset value represents the assets of a Fund less its liabilities.
Sharpe Ratio:	The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.
Standard Deviation:	The deviation of the return stream relative to its own average.
Tracking Error:	The volatility of the difference in returns between a Fund and its Benchmark. Also known as active risk.
% Positive Months:	The percentage of months since inception where the Fund has delivered positive return.

FUND SPECIFIC RISKS

Currency exchange risk:	Changes in the relative values of individual currencies may adversely affect the value of investments and any related income.
Default risk:	The risk that the issuers of fixed income instruments (e.g. bonds) may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
