## MINIMUM DISCLOSURE DOCUMENT

### INVESTMENT AND RETURN OBJECTIVE

The Fund aims to outperform the FTSE/JSE Africa Top 40 index. Tracking error to the index is minimised in the process.

### INVESTMENT PROCESS

The Fund is an equity index fund where returns are enhanced by taking advantage of low risk arbitrage opportunities in the market. Additional benefits are gained from efficient implementation of cash flows, dividend reinvestments, management of corporate actions, use of future discounts and index rebalancing. The Fund aims to remain fully invested in equities at all times.

### WHO SHOULD INVEST

Investors seeking broad based exposure to the large capitalisation sector of the South African equity market. This Fund is appropriate for investors with a long-term investment horizon.

### RISK INDICATOR DEFINITION

These portfolios typically hold meaningful equity and/or offshore exposure which may result in significant capital volatility over all periods. Due to their nature expected long term returns are higher than for the other risk categories.

## FUND COMMENTARY

A decent rally in global markets took place as November was nearing a conclusion. Prior to this, markets flip flopped with no clear direction as the US tech sector initially sold off and then recovered strongly when bargain hunting entered markets and the US Federal Reserve hinted that US interest rates were near the neutral rate. The tech heavy Nasdaq index, which was down over -5% at one point, ended 0.34% up in November, whilst the S&P500 index rose by 1.79% over the same period. Brexit negotiations continued to weigh on the UK and the EU. After eventually managing to strike a deal, UK Prime Minister Theresa May now faces a Herculean task of getting the deal through the House of Commons, who are set to vote on the agreement on the 11th of December. European markets hence struggled with the DAX and FTSE100 indices giving back -1.66% and -2.07% respectively. Amidst the geopolitical uncertainty, the MSCI Emerging Market index (+4.06%) outperformed the MSCI World index (+0.96%). On the home front, the South African Reserve Bank hiked interest rates by 0.25%, which caught markets off guard to some degree considering the desperate need for growth domestically. Meanwhile, another cabinet reshuffle took place as tempers flared at the Zondo commission of state capture, which hints at a bumpy ride till next year's national election.

The JSE All Share index decoupled from global markets by losing -3.17% in what was a tough month. The resources sector bore the brunt of this decline as the FTSE/JSE Resource Index lost -11.88% on the back of a -20.75% collapse in price of Brent crude oil. Financials closed the month up +2.59% and was helped by a stronger rand whilst Industrials were down -0.97%.

The Prescient Equity Top 40 Fund was down -2.63% for the month (gross of fees), ahead the FTSE/JSE Africa Top40 Index (-3.10%).

### Contributors to Performance:

The positions that contributed the most to the performance of the fund for the month were Naspers (+6.57%), Standard Bank Group (+7.26%) and First Rand (+3.87%).

### Detractors from Performance:

The largest detractors from the months' performance were Compagnie Richemont (-17.43%), BHP Group Plc (-11.19%) and Sasol (-16.06%).

## GLOSSARY

**Annualised performance:** Annualised performance show longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

**Highest & Lowest performance:** The highest and lowest performance for any 1 year over the period since inception have been shown.

**NAV:** The net asset value represents the assets of a Fund less its liabilities.

**Current Yield:** Annual income (interest or dividends) divided by the current price of the security.

**CPU:** Cents Per Unit to the Glossary

**Alpha:** Denoted the outperformance of the fund over the benchmark.

**Sharpe Ratio:** The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

**Standard Deviation:** The deviation of the return stream relative to its own average.

**Max Drawdown:** The maximum peak to trough loss suffered by the Fund since inception.

**Dividend Yield:** The weighted average dividend yield of all the underlying equity in the Fund. The dividend yield of each company is the dividends per share divided by the price.

**PE Ratio:** The weighted average price earnings ratio of all the underlying equity in the Fund. The price earnings ratio of each company is the price divided by the earnings per share.

## Fund Specific Risks

**Default Risk:** The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
