INVESTMENT AND RETURN OBJECTIVE

The Fund is priced in Rands and aims to outperform G7 inflation in Euro terms over time while aiming to limit capital losses.

INVESTMENT PROCESS

The Fund invests in money market instruments, capital market instruments and equities with an active asset allocation overlay. The equity component of the Fund is always protected. As the underlying Fund is priced in Euro's the exchange rate volatility between Euro's and Rands are reflected in the price. The feeder fund is invested wholly in the Prescient Global Positive Return Fund.

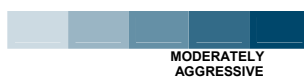
WHO SHOULD INVEST

Investors seeking a hedge against any Rand depreciation while gaining exposure to a risk aware asset allocation offshore fund. This Fund is suitable to investors with a medium to long-term investment horizon.

RISK INDICATOR DEFINITION

These portfolios typically exhibit more volatility and potential for capital losses due to higher exposure to equities and exposure to offshore markets where currency fluctuations may result in capital losses. These portfolios typically target returns in the region of 5% - 6% above inflation over the long term.

FUND COMMENTARY

A decent rally in global markets took place as November was nearing a conclusion. Prior to this, markets flip flopped with no clear direction as the US tech sector initially sold off and then recovered strongly when bargain hunting entered markets and the US Federal Reserve hinted that US interest rates were near the neutral rate. The tech heavy Nasdaq index, which was down over -5% at one point, ended 0.34% up in November, whilst the S&P500 index rose by 1.79% over the same period. Brexit negotiations continued to weigh on UK and the EU. After eventually managing to strike a deal, UK Prime Minister Theresa May now faces a Herculean task of getting the deal through the House of Commons, who are set to vote on the agreement on the 11th of December. European markets hence struggled with the DAX and FTSE100 indices giving back -1.66% and -2.07% respectively. Amidst the geopolitical uncertainty, the MSCI Emerging Market index (+4.06%) outperformed the MSCI World index (+0.96%). On the home front, the South African Reserve Bank hiked interest rates by 0.25%, which caught markets off guard to some degree considering the desperate need for growth domestically. Meanwhile, another cabinet reshuffle took place as tempers flared at the Zondo commission of state capture, which hints at a bumpy ride till next year's national election. The JSE All Share index decoupled from global markets by losing -3.17% in what was a tough month. Bonds rallied with the All Bond index adding 3.87% in November. However, Brent crude oil was the laggard as severe selling pressure, on the back of a diminished global growth outlook, saw a -20.75% collapse in price to end at USD59.14/bbl.

Contributors to performance: Our protection overlay added value as volatility was on the rise. The very conservative credit exposure also helped the Fund. Finally, there were no significant currency positions in place.

Detractor from performance: Our equity exposure, as well as the underweight fixed income exposure detracted value. With emerging market credit spreads widening, the emerging market bond exposure also detracted value. Finally, our overweight of Europe was a detractor in November as well.

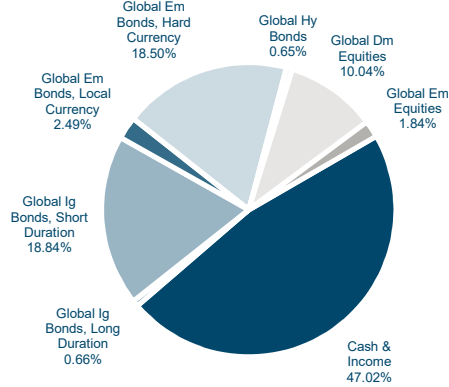

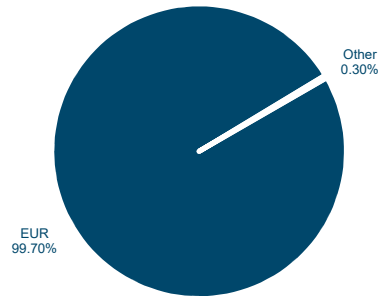

GLOSSARY

Annualised performance: Annualised performance show longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denoted the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Fund Specific Risks

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

Derivatives risk: The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.

Developing Market (excluding SA) risk: Some of the countries invested in may have less developed legal, political, economic and/or other systems. These markets carry a higher risk of financial loss than those in countries generally regarded as being more developed.
