## MINIMUM DISCLOSURE DOCUMENT

### INVESTMENT AND RETURN OBJECTIVE

The Fund aims to deliver returns close to the FTSE/JSE Africa Shareholder Weighted Total Return Index SWIX at low cost. It is not a tracker fund and can out / underperform the SWIX by small amounts over time.

### INVESTMENT PROCESS

The Fund follows an investment policy which firstly endeavours to follow the composition of the SWIX closely and secondly seeks enhancement opportunities and secure for investors an optimum overall return. In addition to investing in physical assets, the Fund can use derivatives to create exposure to the SWIX or subsets thereof in a low cost and efficient manner.

### WHO SHOULD INVEST

Investors who are seeking long term capital growth through exposure to the South Africa equity market by investing in a fund with a low tracking error relative to the SWIX and who are cost conscious.

### RISK INDICATOR DEFINITION

These portfolios typically hold meaningful equity and/or offshore exposure which may result in significant capital volatility over all periods. Due to their nature expected long term returns are higher than for the other risk categories.

## FUND COMMENTARY

The fourth quarter proved to be extremely tough on global markets. Trade war rhetoric, anxiety over a higher than expected interest rate environment, Brexit uncertainty and fears of a rise in populism in the EU all played their part in sending market participants running for the door. The G20 summit where the world's two largest economies managed to place a freeze of furthering the trade war was a slight glimmer of light but by then it was seemingly too late as the S&P500 index fell by -13.97% over the fourth quarter. Meanwhile, fears of a global economic slowdown as the US bull market entered its tenth year, were rife. As such, valuation concerns in the US technology sector saw the tech heavy Nasdaq index get pummeled by -17.54%. Brexit uncertainty and Italy's budget debacle added to market stress. The DAX and CAC40 indices lost -13.78% and -13.89% over the quarter whilst the FTSE100 index gave back -10.41% over the same period. It was no wonder that developed market equities underperformed their emerging market counterparts with the MSCI World index ending -13.74% in the red vs the MSCI Emerging Market index, which lost -7.85%.

The JSE All Share index by comparison had a decent quarter by only losing -4.88%. This move was driven mostly by the Resources and Industrials sectors as the FTSE/JSE Africa Industrial Index and FTSE/JSE Resource Index returned -7.25% and -5.00% respectively for the quarter. The JSE All Bond index rose by 2.80% over the period. For commodities, oil and gold both marched to a completely different beat. Brent crude oil lost a mammoth -34.33% in Q4 as a cocktail of panic over oversupply concerns met worries of a global economic slowdown. Gold rose by 7.42% over the period and was a benefactor of its safe haven status during the time of massive uncertainty.

The Fund returned -3.87% (gross of fees) for the quarter, ahead of the FTSE/JSE SWIX Index (-3.98%). The Fund closed the off the 2018 calendar year down -11.54% (gross of fees), ahead of the FTSE/JSE SWIX Index (-11.67%).

### Contributors to Performance:

The positions that contributed the most to the performance of the fund for the month were Naspers (+4.68%), Anglo American (+16.35%) and BHP Group Plc (+15.22%).

### Detractors from Performance:

The largest detractors from the months' performance were Aspen (-8.34%), First Rand (-1.86%) and Remgro (-3.42%).

## GLOSSARY

**Annualised performance:** Annualised performance show longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

**Highest & Lowest performance:** The highest and lowest performance for any 1 year over the period since inception have been shown.

**NAV:** The net asset value represents the assets of a Fund less its liabilities.

**Current Yield:** Annual income (interest or dividends) divided by the current price of the security.

**CPU:** Cents Per Unit to the Glossary

**Alpha:** Denoted the outperformance of the fund over the benchmark.

**Sharpe Ratio:** The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

**Standard Deviation:** The deviation of the return stream relative to its own average.

**Max Drawdown:** The maximum peak to trough loss suffered by the Fund since inception.

**Dividend Yield:** The weighted average dividend yield of all the underlying equity in the Fund. The dividend yield of each company is the dividends per share divided by the price.

**PE Ratio:** The weighted average price earnings ratio of all the underlying equity in the Fund. The price earnings ratio of each company is the price divided by the earnings per share.

## Fund Specific Risks

**Default Risk:** The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

**Derivatives risk:** The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.
