Fund objective

Abax Balanced is a domestic fund with a mandate to invest across a wide range of local and foreign asset classes. The Fund has a maximum net equity exposure of 75% and a maximum net foreign exposure of 30% and 10% Africa (excl. South Africa). The Fund is suitable for retirement savings.

The Fund's primary objective is to outperform the peergroup (as measured by the ASISA MA High Equity Category Average) on net of fee basis over the medium term**.

The Fund has a moderate to high risk profile, and is suitable for investors seeking high levels of Capital growth and moderate levels of income, who can tolerate the associated high levels of capital volatility.

About the Fund

The Fund is actively managed and draws upon Abax's full skillset: asset allocation, valuation-based equity and fixed income security selection as well as our hedging capabilities.

The Fund is managed by Matthew de Wet and Rashaad Tayob.

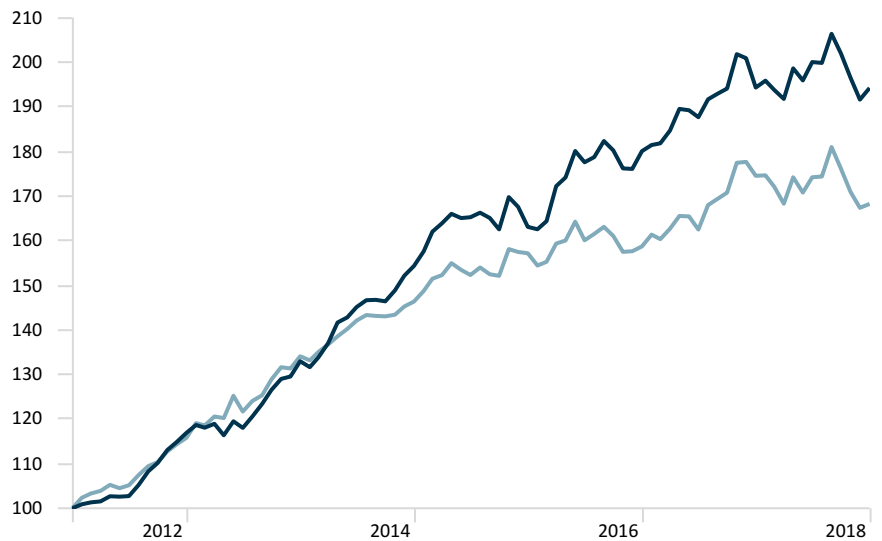

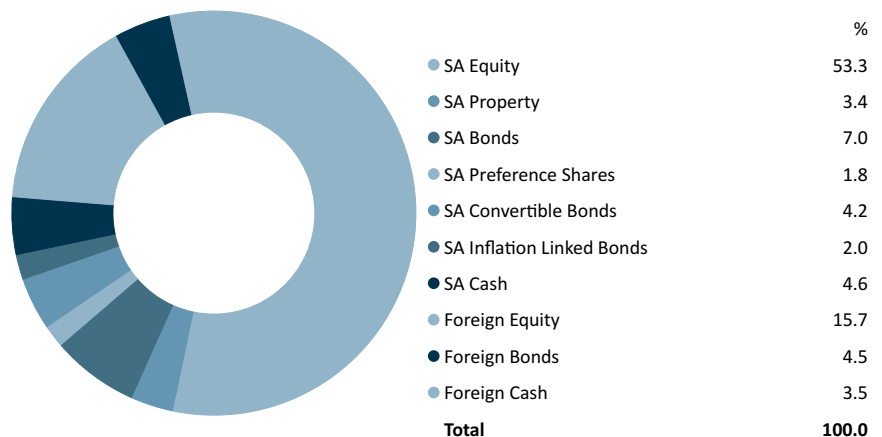

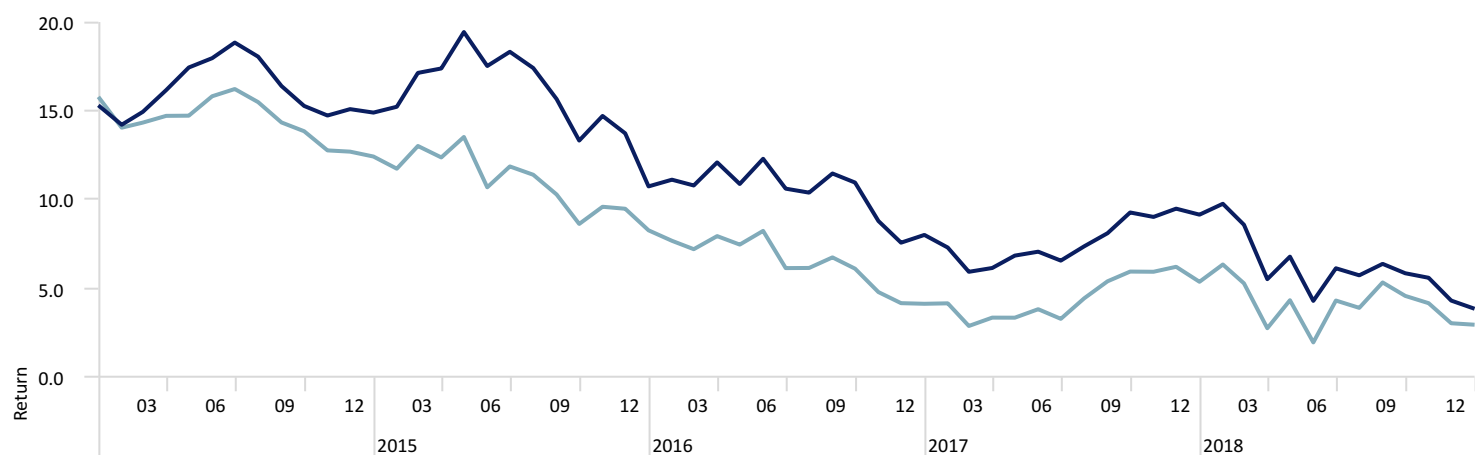

Definitions

Annualised performance - Annualised performance show longer term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest return - The highest and lowest returns for any 1 year over the period since inception have been shown. NAV - The net asset value represents the assets of a Fund less its liabilities.

Sharpe Ratio - The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation - The deviation of the return stream relative to its own average.

Max Drawdown - The maximum peak to trough loss suffered by the Fund since inception.
