### Fund objective

Abax SA Absolute is a domestic fund with a mandate to invest across a wide range of South African asset classes. The Fund has a mandated maximum net equity exposure of 40%. The Fund is suitable for retirement savings.

The Fund's primary objective is to outperform Inflation + 3% p.a., over rolling 3 year periods (net of fees), without any negative 12-month periods.

The Fund has a low to moderate risk profile, and is suitable for investors seeking some capital growth and income without having to assume high levels of capital volatility.

### About the Fund

The Fund is actively managed and draws upon Abax's full skillset: asset allocation, valuation-based equity and fixed income security selection.

The Fund is managed by Philip Liebenberg and Rashaad Tayob.

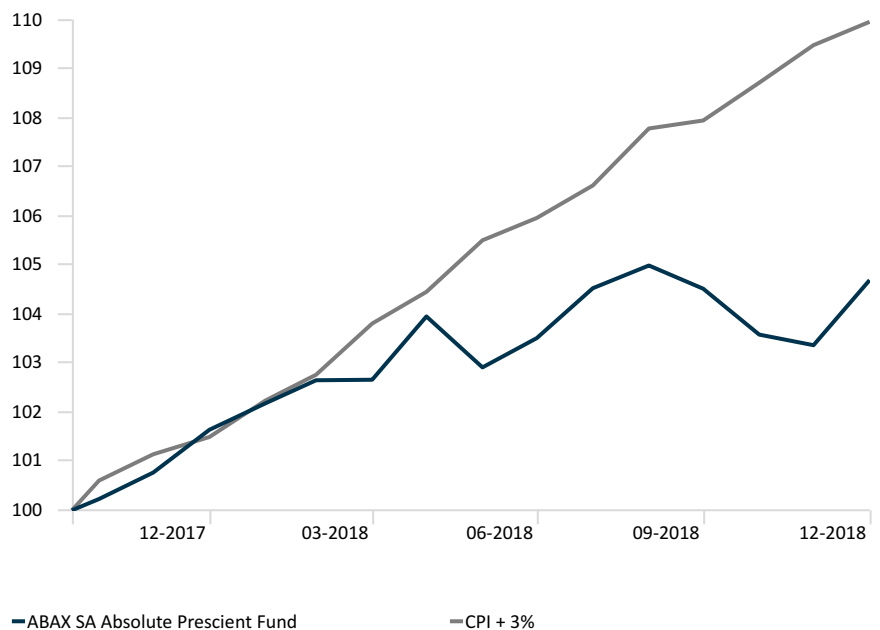

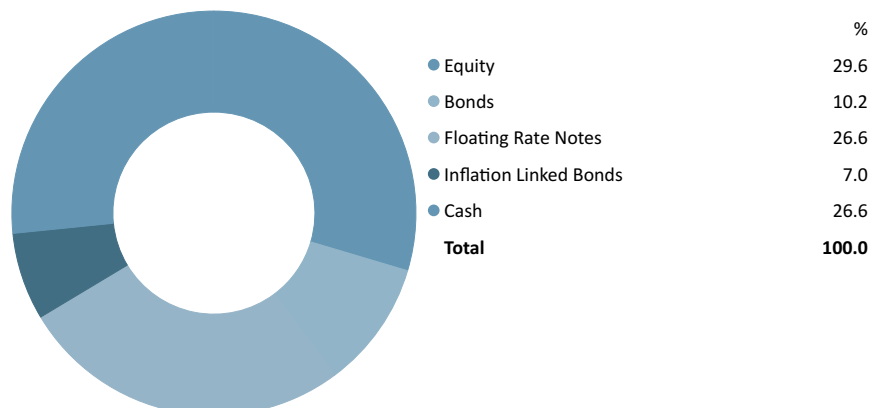

Max Drawdown - The maximum peak to trough loss suffered by the Fund since inception.
