### **MONTHLY COMMENTARY**

and -1.25% respectively for the month of December, with the historic yield of the SAPY ending the month at 9.41%. The yield-to-maturity (YTM) on the Long-Term South African government bond (RLRS) remained flat ending the month at 9.22% (9.22% - 30 November 2018). SA Equites recorded the highest total return (4.25%) for the month of December, followed by SA Bonds (0.64%), SA Cash (0.60%) and SA Property (-1.06%). Quarter-to-date performance, SA Bonds outperformed other asset classes recording a total return of (2.80%) with SA Listed property recording total returns of (-3.99%) over the same period. SA Listed Property (SAPY) continues to underperform other asset classes on a rolling 12-month period, with SA Bonds outperforming with returns of 7.74%, followed by SA Cash (7.29%), SA Equities (-8.53%) and SA Property (-25.26%).

Globally, the FTSE EPRA/NAREIT Developed Net Rental Index, recorded a net total USD return of -6.06% in December. The best performing listed real estate market was Hong Kong, which recorded a total USD return of 3.40% for the month. The US recorded the lowest total monthly USD return of -8.22%. It's been a tough year for investors with most of the major markets around the world delivering weak or negative returns. The global listed real estate markets were not immune to the risk-off sentiment that prevailed in the latter part of the year. The best performing listed real estate market for the year was Japan, which recorded a total USD return of 9.67%, whilst the UK performed the worst with a total USD return of -18.03%.

The Fund's offshore allocation is approximately 46% on a see-through basis. Global real estate operating fundamentals, although moderating, remain overall healthy, Positive GDP growth, low unemployment, wage growth, and moderate inflation all contribute towards a healthy economic backdrop. The valuation of the global listed real estate sector currently seems fair with an estimated FAD (Funds Available for Distribution) yield of 5.25%. Locally, SA centric companies are trading at forward yields above the long-term South African Government Bond proxy (RLRS). Similarly, dual listed offshore companies are trading at attractive forward yields relative to their respective long-term government bond yields. We expect the SA Listed Property Index to achieve inflationary growth in distribution per share over the medium term.




