



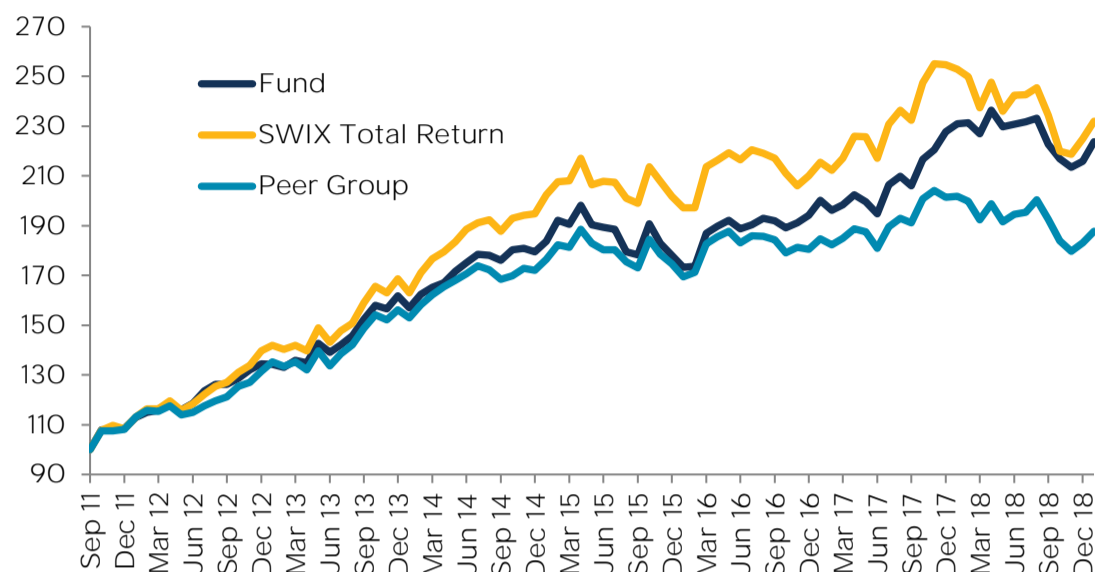
FUND OBJECTIVE & STRATEGY

The ClucasGray Equity Prescient Fund is a SA only, general equity fund. The fund aims to provide long term capital growth ahead of its benchmark (SWIX) and the competing unit trust category by investing in any shares that are listed on the JSE. The fund is a high conviction fund aiming to hold no more than 25 stocks at any one time. Fundamental analysis, a valuation discipline and a belief that inefficient markets create opportunities in mispriced assets underpin our process.

MONTHLY COMMENTARY

The ClucasGray Equity Fund gained 3.6% in January, ahead of both the JSE Swix index and the general equity peer group. Over the last 3 years, the fund is up nearly 9% per annum, compared to the Swix of 5.6% and the peer group of 3.5%.

A number of key holdings performed well in the month - most notably Absa, Standard Bank and Clover, which are 3 of the top 5 holdings in the fund, all gained over 9%. In addition, strong performances from Exxaro, Anglos, Old Mutual and Mondi also benefited the fund. The January trading updates from most of the large retailers proved to be disappointing, highlighting how difficult the consumer environment has been for food and discretionary retailers in South Africa. Notwithstanding a currency which strengthened by over 7% in the month, which would typically boost the outlook for the consumer economy, the share prices of many retailers declined meaningfully in the month.

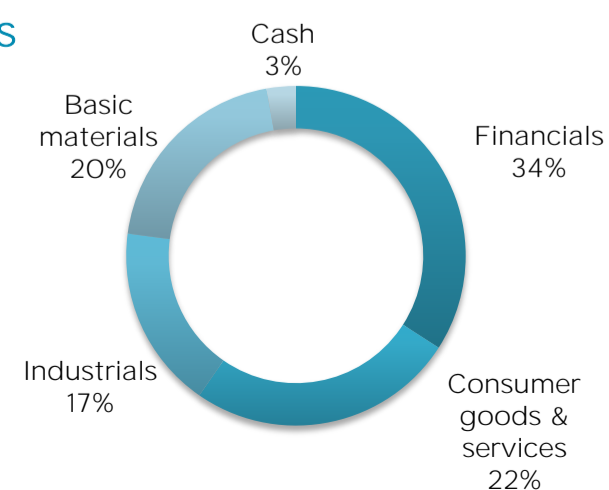

During the phase in period TER's do not include information gathered over a full year.

Transaction Costs(TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER.

Where a current yield has been included for Funds that derive its income primarily from interest bearing income, the yield is a weighted average yield of all underlying interest bearing instruments as at the last day of the month. This yield is subject to change as market rates and underlying investments change.
