INVESTMENT OBJECTIVE

The Long Beach Managed Prescient Fund is an actively managed portfolio which aims to provide real long-term growth in capital. The Fund invests in shares, bonds, cash, ETFs, listed real estate and derivatives, with up to 30% of the portfolio in foreign assets. The Fund may either hold cash and/or make use of derivatives to protect capital in periods of market turbulence. The Fund is managed in accordance with Regulation 28.

Annualised Standard Deviation	12.36	7.21	Global markets continued to struggle with the S&P500 down by -9.03% in December and finishing the year down -4.38% in USD terms. Fears over slowing global growth, in particular for China, and fears over Trump's ongoing trade war, the US government's dysfunction and shutdown over Trump's border wall combined with an illiquid market in December lead to an exaggerated sell-off. This was in contrast to the incoming economic data with US retail sales up 5.1% in December and PMI's which remain at comfortable levels for expansion. The US Fed from a forward guidance position of four expected rates hikes in 2019, has significantly backed off, and is now willing to be 'patient' and assess the incoming data, in other words remain on hold. This supports the view of ongoing growth, although at a more moderate level, and without further economic shocks the recession fears which are priced into the US yield curve look to be exaggerated.

DISCLAIMER FOR FUND SPECIFIC RISK
