## MINIMUM DISCLOSURE DOCUMENT

### INVESTMENT AND RETURN OBJECTIVE

The Fund aims to outperform the FTSE/JSE Africa Top 40 index. Tracking error to the index is minimised in the process.

### INVESTMENT PROCESS

The Fund is an equity index fund where returns are enhanced by taking advantage of low risk arbitrage opportunities in the market. Additional benefits are gained from efficient implementation of cash flows, dividend reinvestments, management of corporate actions, use of future discounts and index rebalancing. The Fund aims to remain fully invested in equities at all times.

### WHO SHOULD INVEST

Investors seeking broad based exposure to the large capitalisation sector of the South African equity market. This Fund is appropriate for investors with a long-term investment horizon.

### RISK INDICATOR DEFINITION

These portfolios typically hold meaningful equity and/or offshore exposure which may result in significant capital volatility over all periods. Due to their nature expected long term returns are higher than for the other risk categories.

## FUND COMMENTARY

It has been a very positive start to the year for equity investors. January saw global equity markets recover most of the losses that were suffered during the back-end of 2018. Despite a prolonged record-breaking partial government shutdown in the US, the S&P500 index gained a massive 7.87% over the month. This was the biggest one month gain since October 2015. Dovish comments from the US Federal Reserve, paired with renewed optimism regarding the outcome of the US and China tariff negotiations induced positive sentiment for risk assets. This was evidenced by a rally in most emerging market currencies relative to the US dollar.

Domestically, the rand strengthened as much as 7.4% whilst the FTSE/JSE All share index returned +2.69% for the month. From a broad sector level, this was led by the Financials (+6.75%), which is unsurprising given the strong rand. The most notable performance coming from ABSA Group, which rallied to close the month up +14.19%. The shares price movement occurred on the back of markets reacting positively to the announcement that long-standing CEO Maria Ramos will step down in April. The Industrials sector lagged the others and closed the month up only +0.99%. This was on the back of lower than expected earnings by some of the local retailers. The market swiftly punished the likes of Mr. Price, Shoprite and Massmart, they closed the month down -9.40%, -13.94% and -11.13% down respectively.

The low risk enhancements that were utilised as part of the Funds' investment process continued to add value. The fund returned 3.00% (gross of fees) comfortably ahead of the benchmark index 2.72%.

### Contributors to Performance:

The positions that contributed the most to the performance of the fund for the month were Naspers (+4.68%), Standard Bank Group (+9.05%) and Anglo American (+6.15%).

### Detractors from Performance:

The largest detractors from the months' performance were Richemont (-3.03%), Sasol (-5.78%) and Shoprite (-13.94%).

## GLOSSARY

**Annualised performance:** Annualised performance show longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

**Highest & Lowest performance:** The highest and lowest performance for any 1 year over the period since inception have been shown.

**NAV:** The net asset value represents the assets of a Fund less its liabilities.

**Current Yield:** Annual income (interest or dividends) divided by the current price of the security.

**CPU:** Cents Per Unit to the Glossary

**Alpha:** Denoted the outperformance of the fund over the benchmark.

**Sharpe Ratio:** The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

**Standard Deviation:** The deviation of the return stream relative to its own average.

**Max Drawdown:** The maximum peak to trough loss suffered by the Fund since inception.

**Dividend Yield:** The weighted average dividend yield of all the underlying equity in the Fund. The dividend yield of each company is the dividends per share divided by the price.

**PE Ratio:** The weighted average price earnings ratio of all the underlying equity in the Fund. The price earnings ratio of each company is the price divided by the earnings per share.

## Fund Specific Risks

**Default Risk:** The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
