INVESTMENT OBJECTIVE

The portfolio will aim to maximize total return for investors by way of a flexible worldwide portfolio actively investing across equities and cash, both locally and internationally.

The Fund has adhered to its policy objective.

We invest in best of class businesses for their quality, strategic competitive edge and value.

FUND COMMENTARY

The US stock market had good reason for a positive performance in December. US employment data remained reasonably healthy. The US Federal Reserve cut its target rate by 0.25% thereby supporting the economy. The surprisingly low US headline inflation figure of +2.7% was good news for capital markets, especially because the cost of shelter, the largest contributor, dropped further. All the other large contributors also moved lower. Earnings revisions for the S&P 500 index continued rising. The announcement of the strong third quarter US GDP of +4.3% further bolstered investor confidence. These collectively led to the traditional 'Santa Claus' rally.

The largest contributors to the Fund's performance over the month came from the South African counters, namely PSG, Capitec and Bidvest. PSG benefited from sustained positive sentiment toward the domestic investment management sector, supported by robust inflows and favourable AUM updates from industry peers. Capitec's continued strong performance is driven by elevated client transaction volumes in Q4. Bidvest's share price continued its recovery following earlier weakness after the September annual results, as investors shifted focus back to the company's long-term fundamentals.

The largest detractors from performance were EssilorLuxottica, Broadcom and Netflix. Information that Alphabet (Google) is planning to launch smart glasses with AI capability affected investor sentiment on the first. Despite Broadcom's strong earnings report and news of a further large order from Anthropic, the stock fell on heightened fears over lower expected gross margins on the expanding AI related revenues. The unexpected news that Netflix is making a bid for Warner Bros Discovery, along with further news that Paramount Skydance is making a rival bid, affected investor confidence.


