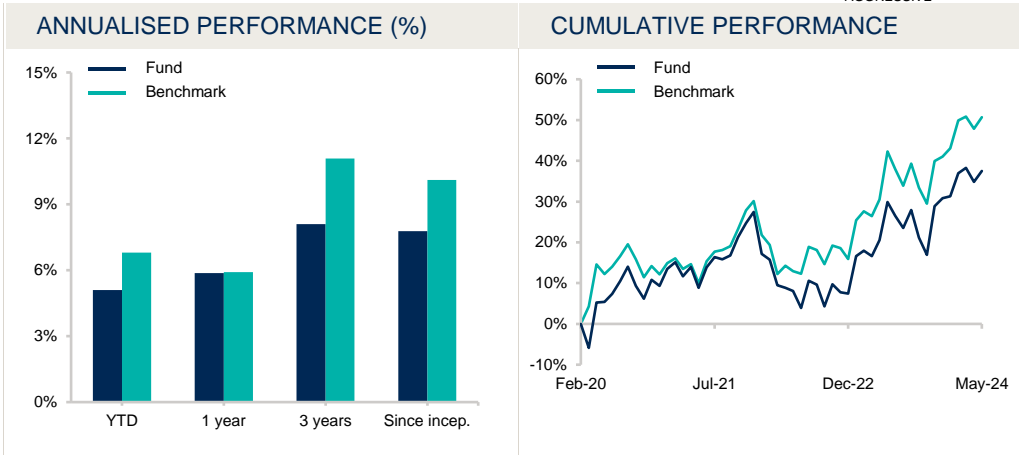
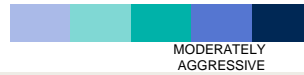
WHO SHOULD INVEST

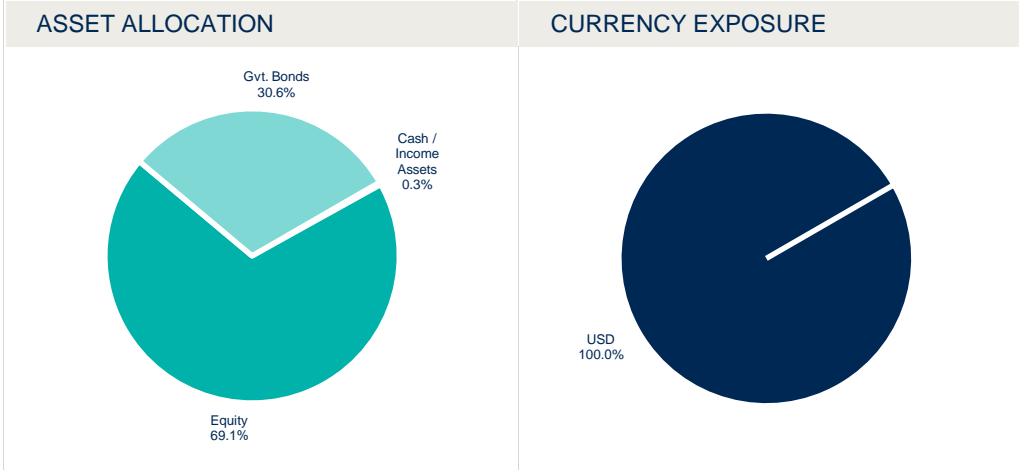
RISK INDICATOR DEFINITION

FUND COMMENTARY

Investors are weighing concerns about the health of the US economy against stronger expectations for early Federal Reserve policy easing. Our Prescient Economic Indicator (PEI), a measure that provides us with valuable insight into economic conditions has shown soft signs of a slowdown in May, largely weighed down by deteriorating economic subcomponents of the index. US data indicates that factory activity shrank at a faster pace as output came close to stagnating and the measure of orders dropped by the most in nearly two years. The softer data in May led US treasury yields lower. The US Treasury Index gained 1.5% in May. Simultaneously we saw the dollar weaken more than 1% against its major peers, and its first monthly decline of 2024.

Euro-area inflation accelerated more than anticipated, further clouding the outlook for ECB interest rates after this week's planned cut. Consumer prices rose 2.6% from a year ago, up from 2.4% in April, according to Eurostat. A measure stripping out volatile components like food and energy also surpassed expectations. They're nevertheless set to reduce the deposit rate from its current record high of 4% in the first week of June. Moving before either the Fed or the Bank of England.

The International Monetary Fund now expects China's economy to grow 5% this year, raising its forecast from 4.6% a few weeks ago to reflect a strong expansion at the start of 2024 and additional support from the government. The IMF said it had revised up both its 2024 and 2025 GDP targets by 0.4% but warned that growth in China would slow to 3.3% by 2029 due to an ageing population and slower expansion in productivity. The IMF has called on Beijing to provide more monetary and fiscal support, including further steps to resolve the housing crisis, which has persisted despite repeated efforts by authorities to put a floor under prices and boost demand.

Commodities mostly moved higher in May, with gold reaching a new intramonth high. Bullion surpassed \$2,400 per ounce as Central Banks continued to diversify their reserves and geopolitical tensions in the Middle East remained elevated. Gold posted a monthly gain of 1.8%, outperforming the Bloomberg Industrial Metals Index, which added 1.4%. Silver surged nearly 16%, bringing its total gain since February to 34.1%. In contrast, oil prices fell by more than 7%.

Global equities gained in May, with the developed market regions outperforming their emerging counterparts. The MSCI World Total Return Index rallied 4.2%, ahead of the Emerging Market Index, which added just 0.3%. US Stocks rebounded from their April slump as weaker than expected economic data and positive momentum in the tech sector boosted. The S&P500 gained nearly 5%, while the tech heavy Nasdaq surged 6.9%. European shares shared in the gains, with the STXE 600 adding 3.3%. Japan's Nikkei added just 0.2%, while in China, the Shanghai Composite lost 0.6% and the Hong Kong's Hang Seng Index rose 2.1%.

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Max Gain: Largest increase in any single month.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Fund Specific Risks

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
