

**FUND OBJECTIVE & STRATEGY**

The Fund aims to generate income in excess of money market rates combined with modest capital growth by investing in a range of fixed income assets including cash, NCD's, preference shares, government and corporate bonds and inflation-linked bonds. The Fund may hold listed property and equity, with weightings limited to the sector classification limits. The Fund aims to generate a gross return of CPI plus 1% - 2% over a rolling 12 to 24 month period whilst having a high degree of capital stability.

The average duration of the funds investments will typically be in the range of 2-4 years.







## QUARTERLY COMMENTARY | DECEMBER 2025

December 2025 concluded a remarkable year for South African bond investors. The ALBI was up 2.7% for the month, gained 8.9% for the quarter and was up 24% for the year. As illustrated in the below chart, this is the highest return from the ALBI in over two decades and, given the fund's significant exposure to bonds, was a key driver of the performance of the fund.

Returns from inflation-linked bonds were also very respectable at 15%, though much of this was delivered by the long end, with the shorter end still delivering a very healthy 9%-12%. Away from bonds, the fund was also a beneficiary if its positioning in Equities (9% allocation) and Property (6% allocation).

The ClucasGray Flexible Income Prescient Fund grew by 6.2% over the quarter and by 17.7% for the calendar year. The fund has grown by a compound rate of 13.6% over 3 years, benefiting from the positive returns generated by the combination of domestic fixed income, equity and property assets. Of more relevance is that these returns compare favourably to the fund's objective of generating returns that exceed inflation plus 2% over a 12 to 24 month rolling period.

The fund asset allocation is set out below. The portfolio is well exposed to bonds (50%) and we increased the bond exposure relative to the last quarter, adding to both inflation-linked bonds as well as participating in the new issuance of a corporate bond. This was funded by reducing NCD's. The exposure to property (6%) and equities (9%) were largely maintained. The cash weight was slightly elevated towards the quarter end but has subsequently been deployed.

Within each asset class we highlight material activity over the quarter.

Within bonds the key changes were a reduction in the R2030 and which was used to increase the exposure to inflation linked bonds including the introduction of a new position in the I2031. We participated in the new issuance of a Santam floating rate bond. Within equities we added three new positions, namely Metrofile, Caxton and Zeda. These were funded via a combination of selling Sun International entirely, reducing BTI and using cash. We exited the position in Metrofile during December on the basis that the corporate action had run its course. Within the property sector we added to the existing holdings of Growthpoint, Redefine and Spear.

Despite significant tailwinds for fixed income assets over the last 12 months, we still believe that the starting point of real yields of 3.5%- 4.5% combined with a benign domestic inflation outlook and the prospect of further interest rate cuts, should provide a favourable backdrop for fixed income investors.

The fund has adhered to its policy objective, and our view is that the current combination of assets leaves the fund well positioned to deliver on its real return objective of inflation plus 2% over a rolling 12-to-24-month period.

The number of participatory units at 31 December 2025 was 233 264 577.
