To provide long-term capital growth to investors and target returns of CPI+4% over rolling 7-year periods. This fund is well diversified across asset classes, actively managed with a higher exposure to global markets and is not Regulation 28 compliant.

- This solution offers a high level of global ex South African exposure compared to Regulation 28 bound funds.


RISK INDICATOR AND WHO SHOULD INVEST

RISK INDICATOR






FUND COMMENTARY

The South African equity market has continued its momentum into January with the FTSE/JSE All Share returning 3.7% for the month, and 44.4% for the year. The FTSE/JSE All Property Index delivered 1% for the month and 36% for the 12-month period. The FTSE/JSE All Bond Index returned 2% in January and 26% for the year. Global equities started the year on a firm foot, with the MSCI All Country World Index returning 3% for the month and 21.9% for the year. The Bloomberg Global Aggregate Bond Index delivered 0.9% for January. The rand closed the month at R16.15/USD.

GLOSSARY

Annualised Performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Total Expense Ratio (TER%): The Total Expense Ratio (TER) is the percentage of the net asset value of the class of the Financial Product incurred as expenses relating to the administration of the Financial Product.

Transaction Costs (TC%): The Transaction Costs (TC) is the percentage of the net asset value of the Financial Product incurred as costs relating to the buying and selling of the assets underlying the Financial Product.

Total Investment Charges TIC (%) = TER (%) + TC (%): The Total Investment Charges (TIC), the TER + the TC, is the percentage of the net asset value of the class of the Financial Product incurred as costs relating to the investment of the Financial Product. It should be noted that a TIC is the sum of two calculated ratios (TER+TC).
