



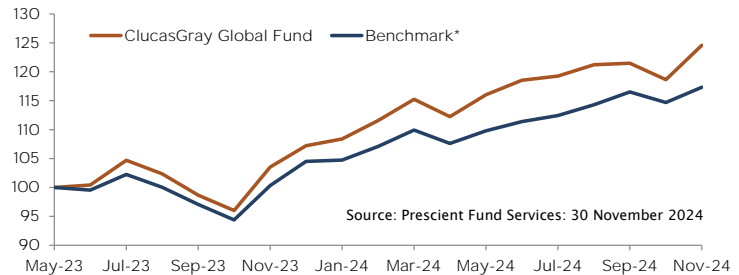
FUND OBJECTIVE & STRATEGY

The investment objective of the Fund is to provide long term capital appreciation and income growth through investment in a concentrated portfolio of assets. The fund is primarily exposed to a focused portfolio of developed market equities. The fund is managed on the basis of the long term ownership of assets and has a bias towards high quality ideas. Investors with a time horizon of three to five years are ideally suited to this fund.

MONTHLY COMMENTARY

The CGGF NAV per share rallied +5.0% in November, outpacing the Morningstar Aggressive Allocation peer group's +2.3% rise. US equities responded favourably to Donald Trump's resounding election victory, pushing the MSCI All Country World index up +3.6%, while performance in most other global markets remained weak in USD terms.

US markets were broadly positive, with strength in large caps (S&P500 +5.7%) and a sharp rally in small caps (Russel 2000 +10.8%) which generally skew more to domestic US activity. US technology (Nasdaq +6.2%) also traded sharply higher. At a World Index level, a rebound in the Consumer Discretionary sector (+7.3%) led on the upside, followed closely by Financials (+6.4%) which was boosted by expectations of a less stringent regulatory environment under the Trump administration. Healthcare (-1.1%) on the other hand, underperformed on fears of increasing regulation, particularly on drug pricing. Political turmoil in France that saw the government succumb to a vote of no confidence weighed on the CAC index (-4.2%) and EU markets overall (Stoxx50 -3.2%).

The recession in global manufacturing continues, with weak PMI's in the EU (45.2) and US (48.4), while China (50.3) expanded marginally for a second month. Services PMI's slowed in the US (52.1) and China (51.5) and slipped into contraction territory in the EU (49.5). US payrolls (+227 000) rebounded from the previous month's hurricane-impacted figures, although the unemployment rate (+4.2%) also ticked up modestly.

The Fund's largest positive contribution came from pharmaceutical distributor, McKesson (+25.5%), which reported strong results and gave a confident outlook, dispelling investor's concerns of a weaker trading environment. Emerson Electric (+22.5%) and Walt Disney (+22.1%) also rallied sharply after reporting results well ahead of investors' expectations. Negative contributions came from Nestle (-6.3%) where the new management team has reset medium-term growth and margin targets and Novo Nordisk (-4.6%) on drug pricing concerns.

No new positions were added during the month, however, the Fund took advantage of market 'noise' to further increase the exposure to Healthcare, adding to life sciences market leader, Thermo Fisher, and increasing the position in Novo Nordisk. The Fund continued to reduce its Energy position, selling down Total Energies, as significant capacity expansion by most major oil producers is expected to raise supply and weigh on oil prices.

At the end of the month the Fund had an underlying exposure to equities of 94.0%, property 1.7%, and cash 4.3%.



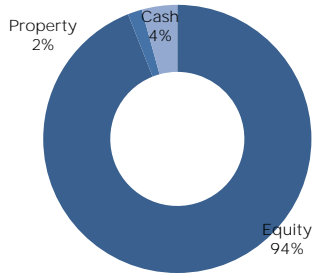

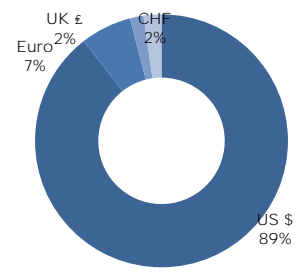

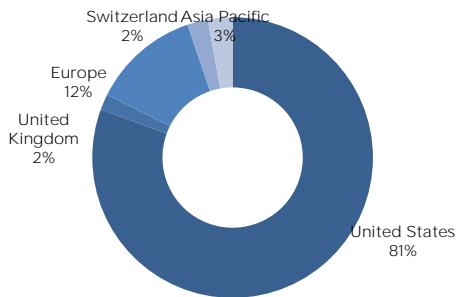
FUND ASSET ALLOCATION



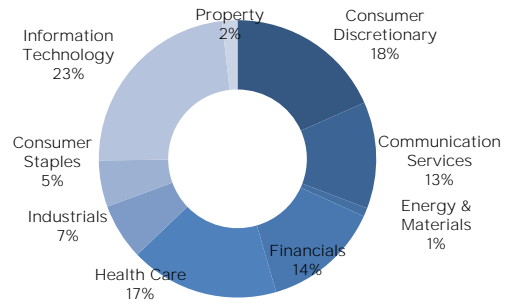
NET CURRENCY EXPOSURE

DISCLAIMER

During the phase in period TER's do not include information gathered over a full year.

Transaction Costs (TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

% Positive Months: The percentage of months since inception where the Fund has delivered positive returns.
