### INVESTMENT AND RETURN OBJECTIVE

The Fund aims to consistently achieve returns above the (ASISA) South African General Equity category over the medium to long term. The Fund is managed systematically to outperform the peer group average return whilst maintaining similar risk characteristics.

### **INVESTMENT PROCESS**

The Fund uses quantitative techniques to dynamically construct a portfolio that is most representative of the general equity category average then employs uncorrelated return enhancement techniques combined with efficient and cost-effective portfolio construction methods to generate outperformance. Although the fund is always fully exposed to the equity market, the use of fixed interest portable alpha techniques to enhance returns can provide exposure to cash and money market instruments, which are uncorrelated and reliable sources of additional return.

#### WHO SHOULD INVEST

Investors seeking broad based exposure to the South African equity market with consistently above average returns. This Fund is appropriate for investors with a long-term investment horizon.





### **FUND COMMENTARY**

Driven by mounting conviction that the U.S. Federal Reserve will begin cutting rates as early as September, global equities climbed to fresh record highs midmonth and closed August stronger. By mid-August, traders were pricing in a 25-basis point cut. Markets largely looked past the policy noise, focusing instead on easing inflation momentum and resilient second-quarter earnings. The MSCI World Index gained 2.6% for the month, supported by U.S. mega-cap strength and a sharp rebound in Chinese A-shares. Dollar weakness provided a tailwind to non-U.S. assets, while gold surged to new all-time highs above \$3,500/oz into the close. In contrast, Brent (-6%) and WTI crude (-7.6%) printed their first monthly decline in four months, amid supply and demand concerns.

United States equities extended their bull run. The S&P 500 rose 2.0% in August, marking its fourth consecutive monthly gain. Small caps outperformed late in the month, though a pullback in technology counters trimmed weekly returns heading into the holiday weekend. Long-end Treasury yields remained volatile, reflecting mixed economic signals.

Europe and the UK also advanced. The Euro Stoxx 50 gained 2.8% in August, buoyed by an improving global risk tone, even as long-dated euro-area yields climbed on supply and fiscal concerns. Eurozone manufacturing rebounded, with the PMI rising to 50.7 (expansion territory) and unemployment dipping to multiyear lows. In contrast, the UK manufacturing sector remained in contraction, pressured by weak demand, tariffs, and rising input costs. Regional performance was led by defensive sectors, aided by a softer dollar.

Emerging markets posted modest overall gains, with the MSCI EM Index rising 1.3%. China led the advance as mainland equities rallied strongly on the back of policy support and bargain hunting. The CSI 300 surged 11.4% in August - its best monthly performance in nearly a year. Japan's Nikkei 225 jumped 6.7%, setting multiple record highs as yen weakness and Al-linked shares, including SoftBank-related names and semiconductors, drove the ascent. In contrast, Latin American markets were muted, with Mexico and Brazil weighed down by idiosyncratic headwinds.

South Africa also delivered robust gains. The FTSE/JSE All Share Index rose 3.5% in August, bringing its year-to-date return to 23.6%. Basic materials once again led sector performance, advancing 11.2%, while technology added 3.4%. The rand strengthened 3.1% against the U.S. dollar during the month, leaving it 6.3% stronger year-to-date, underpinned by stable domestic conditions and improved global risk sentiment.

The top contributors to the Fund's performance for the month were Gold Fields (31.51%), AngloGold Ashanti Plc (21.20%) and Standard Bank Group (6.16%). Detractors included Firstrand Limited (-3.94%), Sibanye Stillwater (-13.11%), and Nedbank Group (-8.91%).

### **GLOSSARY**

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

### **Fund Specific Risks**
