
FUND OBJECTIVE

FUND COMMENTARY

Quarterly Performance

The Portfolio delivered a net return of 4.3% for the fourth quarter of 2025. This compares to the MSCI All Country World Index that grew by 3.4% in the quarter.

Attribution

Companies in the resources, semiconductor and luxury goods sectors drove the majority of the positive fund performance, while exposure to technology and financial services companies detracted from performance in the quarter.

Macro

The “soft landing” narrative for the U.S. economy has transitioned into consensus, supporting a continued risk-on environment. The S&P 500 rallied a further 2.7% in the final quarter, capping off a strong year. The thematic dominance of artificial intelligence evolved; while hardware manufacturers remained robust, some of the larger technology names were weaker on concerns about their extensive capital investments undertaken to drive future earnings growth. In China, the stimulus measures announced earlier in the year have begun to stabilize key economic data points, leading to a modest recovery in the Hang Seng Index. The gold price, while retreating slightly from its Q3 highs, remains elevated, continuing to serve as a key diversifier against lingering geopolitical friction.

Portfolio Construction

At the end of the quarter, exposure remains highly concentrated with the top 10 positions comprising 52% of the fund value. Technology remains a significant overweight position, given higher expected growth from AI related investments and attractive valuations that now offer compelling risk reward skews. The fund has meaningful exposure to financial services and ecommerce companies with superior growth and compelling entry multiples. The balance of the fund is comprised of selective investments in healthcare, payments, luxury goods, and smaller positions in industrial companies.

Outlook

As we turn the page to 2026, US valuations remain high relative to history while European and Chinese assets are more attractively priced. Artificial intelligence continues to advance at a rapid rate, and 2026 could be a defining year for the adoption of this powerful new technology that promises to be a significant growth driver for the global economy. Store of value assets remain important hedges in the context of a fractious global geopolitical environment and high levels of government debt.

We have continued to rotate portfolio exposure toward those investment opportunities where we see attractive valuations and asymmetric risk return profiles. We remain enthusiastic about our core high-conviction positions, particularly those unique businesses with pricing power that are disconnected from the macroeconomic cycle. Our team remains disciplined, adhering to the same risk management framework and valuation-driven philosophy that has served our investors for the past 27 years.

The Fund is managed by Peregrine Capital International. Peregrine Capital International employs a bottom-up stock selection process based on rigorous and disciplined fundamental research, drawing on experience of covering the sectors and companies over many years. Peregrine Capital International focuses its time on building detailed knowledge of specific companies, rather than predicting the economic trends or taking a view on overall markets. The Fund mandate is founded on the UCITS principles for a general equity fund, and position sizes are limited per these regulatory restrictions. The fund adhered to the investment policy objectives.

CALCULATION OF THE NAV AND PRICE

INVESTMENT PERFORMANCE
