

Strategy

The fund aims to achieve long-term capital growth from an actively managed portfolio consisting of pan-European equities. The Portfolio Manager's investment philosophy is anchored on the belief that companies with quality characteristics such as stable earnings growth, attractive/improving returns on capital, and high free cash flow are rewarded by the stock market over time. Over the long term, shareholder returns follow company returns and a company's return over the long term is driven by how efficiently a company converts accounting profits into cash profits, the strength and durability of the company's competitive position which defines their ability to grow, and management's ability to protect internal culture and allocate capital well. The Manager's analytical efforts are spent on understanding which businesses can maintain their earnings growth and which are improving more than the market discounts. His valuation framework is focused on mitigating drawdown risk. ESG is an integral part of the analysis of the quality of a business.

Objectives & Investment Policy

Objective: The fund aims to achieve capital growth over time.

Investment Policy: The fund invests at least 70% (and normally 75%) of its assets, in equities of companies listed on European stock exchanges. The fund may also invest in money market instruments on an ancillary basis.

Investment Process: In actively managing the fund, the Investment Manager considers growth and valuation metrics, company financials, return on capital, cash flows and other measures, as well as company management, industry, economic conditions, and other factors. The Investment Manager considers ESG characteristics when assessing investment risks and opportunities. In determining ESG characteristics, the Investment Manager takes into account ESG ratings provided by Fidelity or external agencies. The fund aims to achieve an ESG score of its portfolio greater than that of its benchmark. Through the investment management process, the Investment Manager aims to ensure that investee companies follow good governance practices. Derivatives and Techniques: The fund may use derivatives for hedging and for efficient portfolio management.

Benchmark: MSCI Europe Index, a broad market index that does not take into account ESG characteristics. Used for: risk monitoring, investment selection and performance comparison. The fund invests in securities of the benchmark, however, the management of the fund is discretionary, therefore the fund may invest in securities not included in the benchmark, and its performance over any period may or may not deviate significantly from that of the benchmark.

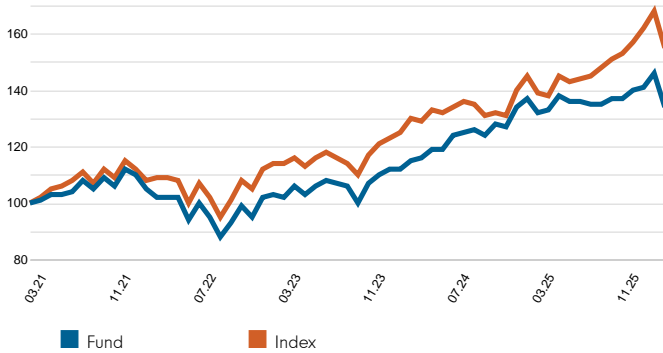

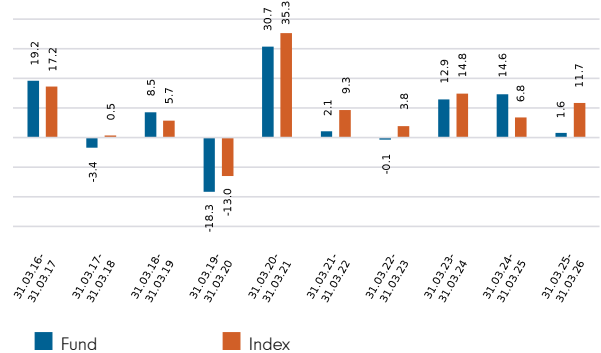
