## **Investment Objective & Strategy**

The WealthStrat Cautious Prescient Fund of Funds will aim to deliver high levels of income and capital stability. The manager shall have limited flexibility in terms of asset allocation and shall not be precluded from continually varying the underlying exposure to both local and offshore assets. The Fund will employ asset and limited geographical allocations to reflect changing economic and market conditions to maximise returns over the long term, the WealthStrat Cautious Prescient Fund of Funds will, apart from assets in liquid form, consist solely of participatory interest in Collective Investment Schemes which will invest in a diversified mix of assets, including but not limited to equities, property, preference shares, money market and fixed interest instruments. The equity allocation will be managed at a maximum effective exposure, including offshore equity, up to 40%. The underlying collective investment schemes are permitted to invest in listed and unlisted financial instruments in line with conditions as determined by legislation from time to time. The underlying portfolios will predominantly invest in South African markets but is however permitted to include investments in offshore jurisdictions subject to the investment conditions determined by legislation from time to time.

#### **Quarterly Fund Commentary**

Conservative investors generated decent returns in the third quarter of 2025. Local bonds delivered strong returns over the quarter, as a broad-based decline in yields drove bond prices higher across the curve. The higher starting yield on cash and short-dated nominal cash instruments continued to deliver a stable return profile, benefiting low equity portfolios. However, the rand's appreciation during the quarter was a headwind for offshore equities, detracting from overall performance.

The WealthStrat Cautious Prescient FoF returned +4.4% for the quarter and has generated a return of +12.8% over the past year.

The portfolio remains diversified in terms of its exposure to various asset classes, and we remain confident in its ability to deliver inflation-beating returns over the long term, independent of the market environment.

#### Asset Allocation

Local bonds constitute the majority of the portfolio's asset allocation, including investments in corporate, government and inflation-linked bonds. South African bonds delivered strong returns over the quarter, as a broad-based decline in yields drove bond prices higher across the curve. Returns were especially pronounced in bonds with bnger dated maturities, as the yield on 10-year SA government bonds decreased meaningfully over the quarter, subsequently lifting bond prices with longer duration. The rally was supported by renewed global demand for Emerging Market Debt (EMD) towards the end of the quarter, coupled with South Africa's high real yield differential, easing inflation, relative rand stability and sustained credibility of the South African Beserve Bank (SARB). Local equities posted strong returns for the quarter, supported by broad-based gains across asset classes. The trend for 2025 has undeniably been the Resources sector, posting 46.8% over the quarter, as both gold and platinum prices are up meaningfully in the quarter. This exceptional performance pushed the sector's year-to-date return to 104.9%, effectively doubling in value since the start of the year. Major contributors included Gold Fields, Northam Platinum, and Sibanye-Stillwater, all of which gained more than 50% over the year. The Industrials sector (+3.7%) posted modest gains over the quarter, with strong performances from index heavyweights Naspers and Prosus helping the sector meaningfully. Financials (+0.3%) was the weakest performing sector over the quarter, with banking stocks such as Firstrand, Standard Bank and ABSA posting positive gains, whereas insurers such as Discovery and OUTsurance ended the quarter in negative territory. Global equity markets delivered broadly positive returns in the third quarter of 2025, supported by easing trade tensions, ongoing enthusiasm around artificial intelligence (AI), and rising expectations for near-term Federal Reserve rate cuts. Growth stocks outpaced value stocks, mainly driven by renewed

#### **Fund Selection**

The contribution from fund selection was mixed for the quarter.

Nedgroup Investments Core Bond delivered strong performance over the quarter, largely driven by positive contributions from medium and long dated SA government bonds. This peer cognisant SA bond strategy aims to outperform peers and its FTSE/ISE All Bond Index benchmark by closely tracking the level of interest rate risk or duration taken on by the relevant peer subset. The fund benefited from strong returns from the 7-12 years and 12+ years areas of the yield curve, which benefited from lower yields (and higher prices) over the quarter.

Ninety One Diversified Income delivered strong performance over the quarter, outperforming its STeFI Composite benchmark and delivering second quartile performance relative to the peer group. Returns over the quarter were supported by good performance from the SA bond market. The fund's exposure to the long end of the yield curve added to performance as the curve flattened (longer-dated yields fell more than shorter-dated yields). Bond yields fell materially after the South African Reserve Bank announced it would focus on the lower end of its inflation target range. Listed property also performed well and added to performance, as did the fund's credit exposure, which was helped by credit spread tightening.

The PSG Equity Fund delivered good absolute performance in a strong equity market environment in the third quarter. On a relative basis, however, the outcome was third quartile performance versus the peer group. The fund benefited from a number of holdings in the Resources sector over the quarter, most notably the positions in Northam Platinum, Anglogold Ashanti, Valterra Platinum and Barrick Mining Corp. These gains were offset by detracting positions in Anheuser-Busch InBev, Discovery and The Foschini Group.

During the third quarter, the WealthStrat Cautious Prescient FoFs local equity core was restructured to include STANLIB Enhanced Multi Style Equity, Steyn Capital Equity Prescient, 360NE BCI SA Equity and Methodical BCI Equity, which was funded by a full sale of 10X S&P SA Top 50 Tracker Fund and a trim of Aylett Equity Prescient, Fairtree SA Equity Prescient and PSG Equity. In addition, the Truffle SCI General Equity was switched to the Truffle SCI SA Equity SA version of the fund.

#### Summary

We are pleased that the portfolio delivered a solid return over the third quarter, with most major asset classes posting positive returns over the quarter. The portfolio continues to be allocated to a diverse range of attractively priced local and global asset classes. We are confident that it will be able to deliver on its investment objective over the long term.

## Glossary

Annualised performance: Annualised performance shows longer term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest return: The highest and lowest returns for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Max Gain: Largest increase in any single month

#### **Fund Specific Risks**
