INVESTMENT AND RETURN OBJECTIVE

The Fund aims to achieve real returns over the long term and to outperform the ASISA category average of the Worldwide - Multi Asset - Flexible Funds over a full market cycle by maintaining meaningful exposure to growth assets like equities.

INVESTMENT PROCESS

The Fund invests across a range of asset classes, both domestically and offshore. The asset allocation is with reference to the long-term strategic allocation, but with tactical asset allocation views overlayed in order to capitalise on market opportunities and for risk management. The portfolio comprises best-of-breed asset class specialist funds as well as asset class replication to reduce costs.

WHO SHOULD INVEST

Investors seeking real returns over the long term and who want to diversify and reduce their risk of being exposed to a single asset manager. The Fund is suitable for investors with a medium to long-term investment horizon and is TFSA compliant.

RISK INDICATOR DEFINITION

These portfolios typically exhibit more volatility and potential for capital losses due to higher exposure to equities and exposure to offshore markets where currency fluctuations may result in capital losses. These portfolios typically target returns of 6% above inflation over the long term.

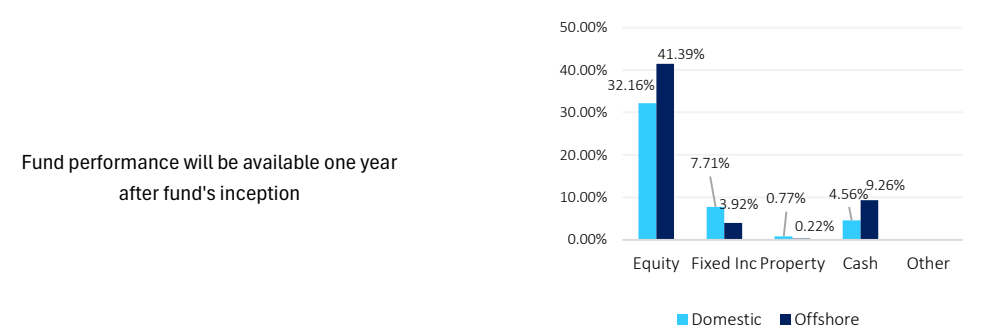


ANNUALISED PERFORMANCE (%)

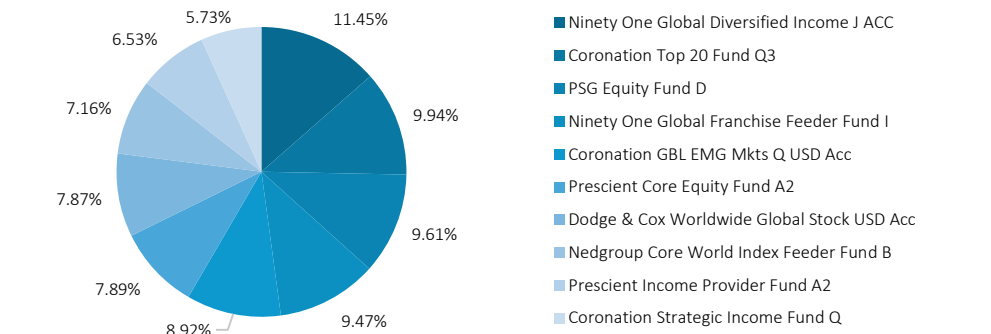

GLOSSARY

- Fund of Funds:** A Fund of Funds is a portfolio that invests in portfolios of collective investment schemes, which levy their own charges, which could result in a higher fee structure for these portfolios.
- Annualised performance:** Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.
- Highest & Lowest performance:** The highest and lowest performance for any 1 year over the period since inception have been shown.
- NAV:** The net asset value represents the assets of a Fund less its liabilities.
- Current Yield:** Annual income (interest or dividends) divided by the current price of the security.
- CPU:** Cents Per Unit
- Alpha:** Denotes the outperformance of the fund over the benchmark.
- Sharpe Ratio:** The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.
- Standard Deviation:** The deviation of the return stream relative to its own average.
- Max Drawdown:** The maximum peak to trough loss suffered by the Fund since inception.
- % Positive Month:** The percentage of months since inception where the Fund has delivered positive return.

FUND SPECIFIC RISKS

- Default Risk:** The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

The portfolio has adhered to its policy objective and there were no material changes to the composition of the portfolio during the quarter.

QUARTERLY FUND COMMENTARY

South African financial markets delivered a standout performance in 2025, supported by improving macroeconomic stability and a broad-based rally across asset classes. The South African Reserve Bank revised its 2025 GDP growth forecast modestly higher to around 1.2–1.3%, following stronger-than-expected second-quarter growth of 0.8% quarter-on-quarter. Investor sentiment improved after South Africa exited the FATF greylist, received a credit-rating upgrade, and benefited from easing inflation and disciplined monetary policy. Headline CPI moderated toward the lower end of the target range, enabling cumulative repo-rate cuts of more than 100 basis points. Equities led the charge. The FTSE/JSE All Share Index rose by over 40% for the year, with gains heavily concentrated in the Resources sector, which surged more than 120%. This was driven by record-high gold and platinum prices amid geopolitical uncertainty and central bank buying. Gold equities delivered exceptional returns, masking weakness elsewhere. Consumer-facing sectors struggled as high unemployment and pressured household finances weighed on spending, highlighting persistent structural challenges. The rally extended beyond equities. Bonds delivered strong double-digit returns as inflation eased and yields declined, with the 10-year government bond yield falling below 9% for the first time in several years. Listed property rebounded as management teams reduced leverage, while money-market assets provided steady, defensive returns. Overall, South African assets reflected renewed confidence within a still-fragile economic backdrop. Global markets also posted solid gains, with non-US equities outperforming the United States for the first time in several years. The MSCI World Index returned just over 20% for the year, supported by resilient earnings growth, easing inflation, and expectations of further monetary policy easing in 2026. A weaker US dollar and more attractive valuations outside the United States supported strong performance across Europe, Asia, and emerging markets. US equities nevertheless delivered another double-digit year, despite valuation concerns, with market leadership gradually broadening beyond mega-cap technology stocks. Emerging markets benefited from interest-rate cuts by the Federal Reserve, with Korea and Taiwan leading returns on strong demand for AI-related technology. Commodity-exporting markets such as Chile and South Africa also performed well, while India tracked the broader EM index. China gave back some of the earlier gains in the final quarter of 2025 as investors took profits after a strong performance for much of the year. Overall, offshore assets reflected a more balanced global recovery as 2025 came to a close.
