

Abax SA Balanced Prescient Fund is a domestic fund focusing on high risk-adjusted returns, balanced across local asset classes with maximum 75% equity and no foreign exposure. The Fund is Regulation 28 compliant.

The objective is to outperform the peer group on a net of fee basis and is suitable for investors seeking high levels of capital growth and moderate levels of income, who can tolerate the associated high levels of capital volatility. Time horizon: 5 years plus.

The Fund is actively managed and draws upon Abax's full skillset: asset allocation, valuation-based equity and fixed income security selection as well as our hedging and hybrid capabilities.

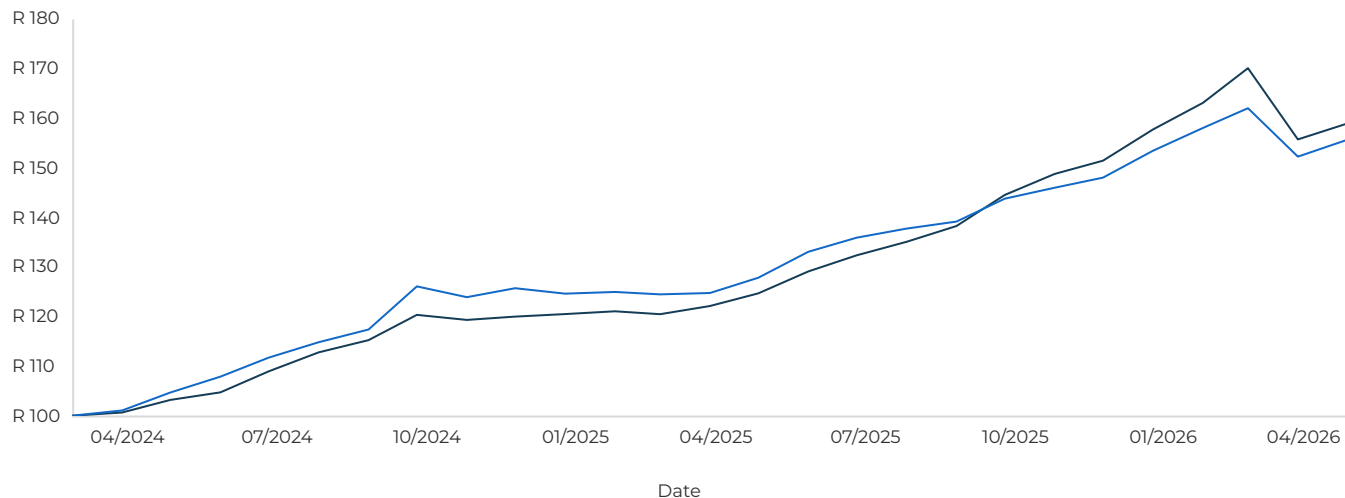

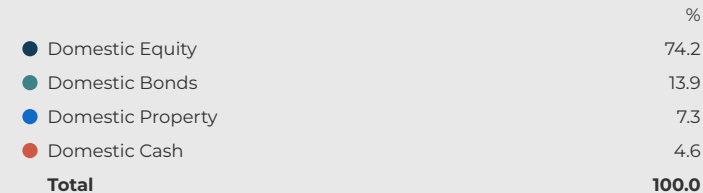

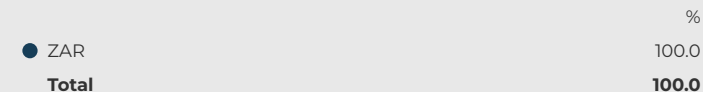

DEFINITIONS & RISKS

Annualised Performance: Longer term performance rescaled to a 1-year period and is the average return per a year, per period. Actual figures available on request.

Default Risk: The issuers of fixed income instruments (e.g. bonds) may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
