INVESTMENT OBJECTIVE

To provide long-term capital growth to investors and target returns of CPI+4% over rolling 7-year periods. This fund is well diversified across asset classes, actively managed with a higher exposure to global markets and is not Regulation 28 compliant.

RISK INDICATOR AND WHO SHOULD INVEST

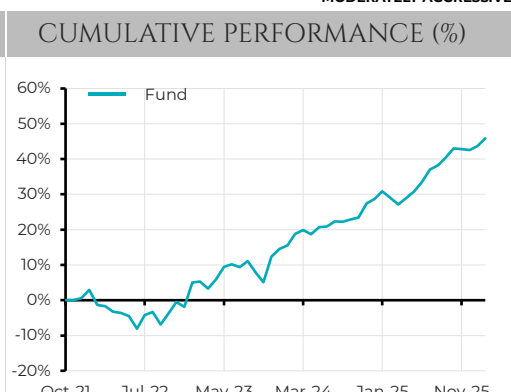

RISK INDICATOR



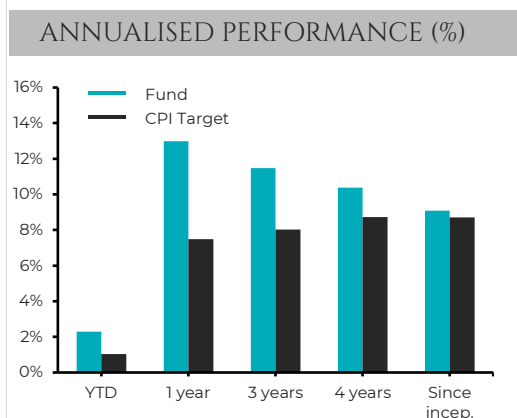

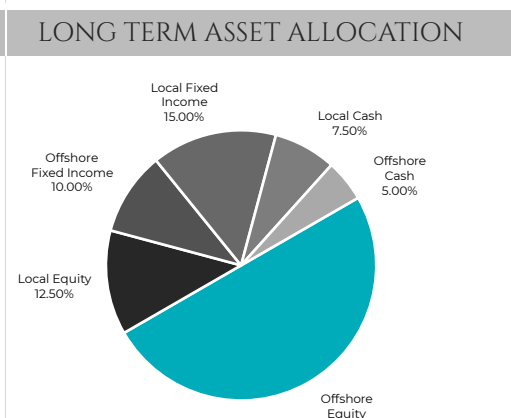

FUND COMMENTARY

February was a positive month for most asset classes, although the US-Israeli strikes against Iran took place after financial markets had closed for the month. The FTSE/JSE All Share Index delivered 7% for the month and returned 54.5% for the year. The FTSE/JSE All Property Index delivered 6.6% for the month and an impressive 44.7% for the 12-month period. The FTSE/JSE All Bond Index returned 1.7% for February and 28.2% for the year. The MSCI All Country World Index posted a modest gain of 1.3% for the month and 24.2% for the year. The Bloomberg Global Aggregate Bond Index delivered 1.1% for February.

The rand closed the month at R15.94/USD.

GLOSSARY

Annualised Performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Total Expense Ratio (TER%): The Total Expense Ratio (TER) is the percentage of the net asset value of the class of the Financial Product incurred as expenses relating to the administration of the Financial Product.

Transaction Costs (TC%): The Transaction Costs (TC) is the percentage of the net asset value of the Financial Product incurred as costs relating to the buying and selling of the assets underlying the Financial Product.

Total Investment Charges TIC (%) = TER (%) + TC (%): The Total Investment Charges (TIC), the TER + the TC, is the percentage of the net asset value of the class of the Financial Product incurred as costs relating to the investment of the Financial Product. It should be noted that a TIC is the sum of two calculated ratios (TER+TC).
