

# PRESCIENT CORE CAPPED EQUITY FUND (A2)

## MINIMUM DISCLOSURE DOCUMENT

### INVESTMENT AND RETURN OBJECTIVE

The Fund aims to deliver returns close to the FTSE/JSE Africa Capped Shareholder Weighted Total Return Index at low cost. Although the Fund is structured similarly to the Capped SWIX, it can out / underperform the Capped SWIX by small amounts over time.

### INVESTMENT PROCESS

The Fund follows an investment policy which firstly endeavours to follow the composition of the Capped SWIX closely and secondly seeks enhancement opportunities to secure for investors an optimum overall return. In addition to investing in physical assets, the Fund can use derivatives to create exposure to the Capped SWIX or subsets thereof in a low cost and efficient manner.

### WHO SHOULD INVEST

Investors who are seeking long term capital growth through exposure to the South Africa equity market by investing in a fund with a low tracking error relative to the Capped SWIX and who are cost conscious.

### RISK INDICATOR DEFINITION

These portfolios typically hold meaningful equity and/or offshore exposure which may result in significant capital volatility over all periods. Due to their nature expected long term returns are higher than for the other risk categories.

## FUND COMMENTARY

Despite ending on a positive note, global equity markets were notably unsteady heading into August. A dangerous mix of underwhelming earnings—particularly from the U.S. technology sector—combined with weak labor market data hinting at an economic slowdown, a major yen-funded carry trade unwind from Japan, and escalating geopolitical tensions in both the Middle East and Russia, sent a stunning shockwave through the markets. The MSCI World Index dropped 6.40% in just the first three trading days of the month, while the VIX Index spiked over twenty points, reaching levels last seen in 2020. The bears eventually calmed down as the month progressed, and normalcy returned. Softer inflation numbers and dovish commentary once again provided the tailwind for stronger market performance. The MSCI World Index concluded the month up 2.64%, while the S&P 500 Index in the U.S. gained 2.43%. European markets, although still playing catch-up to their U.S. counterparts, were similarly strong, with the Eurostoxx posting a solid 3.74% gain. Local currency depreciation in Japan helped the Nikkei to a positive 1.77% print in U.S. dollars. Emerging markets were broadly firmer in August, although the MSCI EM Index posted a relatively modest 1.61% return, largely moderated by weakness in China, where the CSI 300 Index dropped 1.77%.

The local market was similarly strong, with the FTSE/JSE All Share Index reaching all-time highs intra-month to close 1.38% higher, despite notable weakness in the Resources sector, which fell 10.11% as the local currency gained over 2% against the U.S. dollar. The Financials sector benefited once again, rising 5.51% for the month, with Industrials close behind, registering a 4.00% return.

The FTSE/JSE Capped Shareholder Weighted Index closed the month up 1.29%. The Prescient Core Capped Equity Fund outperformed the benchmark, rising 1.90% (gross of fees) for the month.

### Contributors to Performance:

The positions that contributed most to the absolute performance of the Fund for the month were Standard Bank Group (+8.22%), FirstRand Limited (+5.24%) and Naspers (+4.42%).

### Detractors from Performance:

The largest detractors from the month's absolute performance were Gold Fields (-22.32%), Anglo American (-5.11%) and Impala Platinum (-17.38%).

## GLOSSARY

**Annualised performance:** Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

**Highest & Lowest performance:** The highest and lowest performance for any 1 year over the period since inception have been shown.

**NAV:** The net asset value represents the assets of a Fund less its liabilities.

**Current Yield:** Annual income (interest or dividends) divided by the current price of the security.

**CPU:** Cents Per Unit to the Glossary

**Alpha:** Denotes the outperformance of the fund over the benchmark.

**Sharpe Ratio:** The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

**Standard Deviation:** The deviation of the return stream relative to its own average.

**Max Drawdown:** The maximum peak to trough loss suffered by the Fund since inception.

**Dividend Yield:** The weighted average dividend yield of all the underlying equity in the Fund. The dividend yield of each company is the dividends per share divided by the price.

**PE Ratio:** The weighted average price earnings ratio of all the underlying equity in the Fund. The price earnings ratio of each company is the price divided by the earnings per share.

## Fund Specific Risks

**Default Risk:** The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

**Derivatives risk:** The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.
