The Fund's investment objective is to achieve long term capital growth by investing in global equity markets.

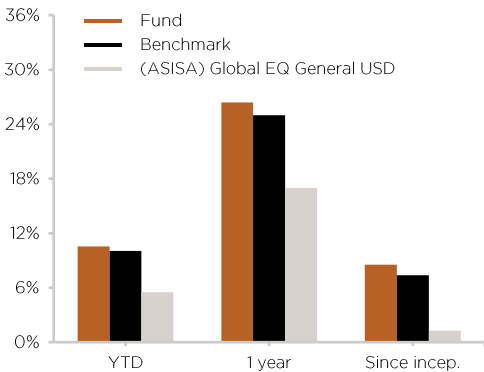

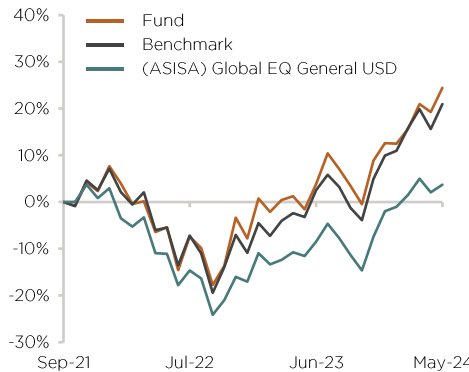
**RISK INDICATOR**

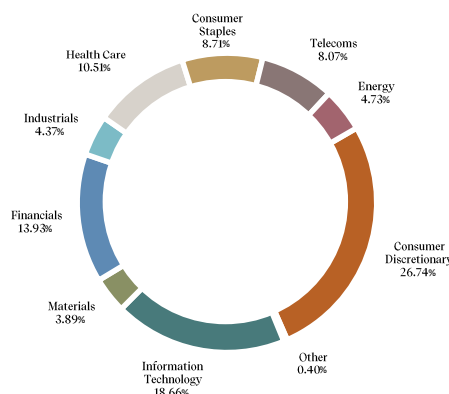

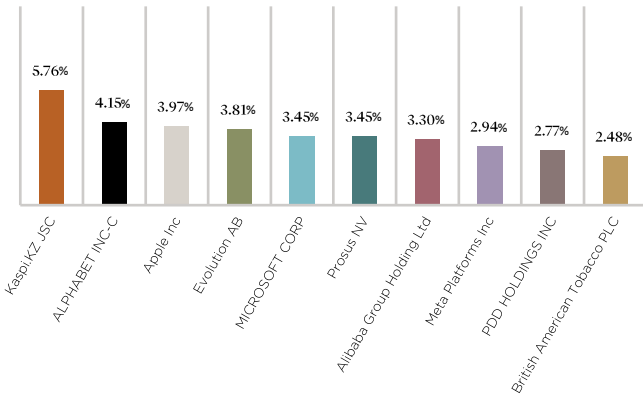

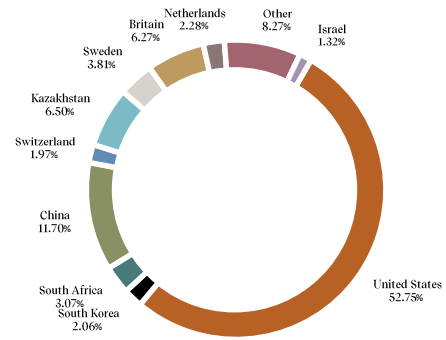

MARKET COMMENTARY

The Fund returned 4.37% for the month, underperforming the benchmark by 0.21%. Global markets enjoyed strong performances in May with the S&P Global 1200 index increasing 4.58%, the MSCI ACWI climbing 4.06%, technology-heavy Nasdaq rising 6.4% and the MSCI Emerging Markets Index increasing 0.57% (all in USD).

The US market climbed 4.8% for the month, driven by strong corporate earnings, while a cooling in the labour market, spurred hopes of interest rate cuts later this year. Despite European inflation again rising in May, the equity market enjoyed a strong month, rising 4.8%, as the market anticipated interest rate cuts from the European Central Bank to start in early June. Within emerging markets, Taiwan had a strong month, driven by continued investors' appetite for AI-related technology businesses and chip makers. China was 2.4% higher, however, investors remain cautious about the economic outlook, despite recent policy measures and the IMF upgrading the Chinese real GDP growth to 5% for the year. Ongoing geopolitical tensions and lower energy prices weighed on Middle Eastern markets as well as Indonesia. On a sector level, returns were driven by information technology and utilities, where the Fund has underweight holdings. Overweight in communication services added to performance. Energy was the second worst-performing sector during the month, with Brent Oil falling 7.1%. Despite the consumer discretionary sector being the worst-performing sector for May, although still marginally higher, the Fund's large overweight to the sector, driven by bottom-up stock picks, added 103 bps to relative performance.

Noteworthy portfolio actions over the month include partially switching the position in JD.com into a larger holding in Pinduoduo, with both JD.com and Pinduoduo releasing results that beat the market's expectations during the month. The existing position in Qualcomm was trimmed into strength, while the holdings in Tencent, Verallia and Amgen were sold following strong share price performances. Other portfolio actions include increasing the existing position in Evolution, while new positions were initiated in CNH Industrial, Netflix and Goldfields.

Notable contributors to performance were positions in Kaspi (+49 bps absolute and relative), Apple (+48 bps absolute, -6 bps relative), Pinduoduo (+31 bps absolute and relative) and Crocs (+24 bps absolute and relative). Notable detractors from performance over the month came from TBC Group (-18 bps absolute and relative), Evolution (-16 bps absolute and relative) and Samsung Electronics (-10 bps absolute, -7 bps relative). The underweight holding in Nvidia detracted 68 bps from relative performance post following the release of a strong set of results and ongoing demand for AI-related technologies.

The Fund's positioning remains largely unchanged with slight underweights in the cyclicals and defensives in favour of technology names. The Fund remains overweight Chinese Technology shares and Kazakhstan through positions in Kaspi and Halyk. We are underweight Japanese as well as US technology shares as we do not believe the risk-reward is attractive at these levels.



### Glossary

**Annualised Performance:** Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

**Highest & Lowest Performance:** The highest and lowest performance for any 1 year over the period since inception have been shown.

**NAV:** The net asset value represents the assets of a Fund less its liabilities.

**Current Yield:** Annual income (interest or dividends) divided by the current price of the security.

**Sharpe Ratio:** The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

**Sortino Ratio:** A measure of the risk-adjusted return of a portfolio. It is a modification of the Sharpe ratio but only penalises the returns falling below a user specified target, or required rate of return, while the Sharpe ratio penalises both upside and downside volatility equally.

**Standard Deviation:** The deviation of the return stream relative to its own average.

**Max Drawdown:** The maximum peak to trough loss suffered by the Fund since inception.

**Max Gain:** Largest increase in any single month.

**% Positive Month:** The percentage of months since inception where the Fund has delivered positive return.

**Performance Fee Cap:** The maximum performance fee that can be charged over a specified period

### Specific Risk
