
**Risk Indicator Definition**


**RISK INDICATOR**



MARKET COMMENTARY

Global credit markets marked time over January with the iTraxx XOver spread index selling off a couple of basis points (bps) to end the month at 247 bps. This level implies a 18.35% probability of default with a 40% recovery, or looking at it another way, the index is currently priced for 14 names defaulting over the life of the index with an average recovery of 40%. When one considers that the highest number of defaults in any historic series was 10, it would suggest that the current spread level should more than compensate investors for losses due to credit events. This does tie up with investment theory, as one should expect a slight excess return to risk. In return space the total return index delivered 0.28% in EUR over the month, which resulted in the year-on-year number dropping from 8.69% at the end of December to 7.64% at the end of January.

On the default side of things, the recovery auction of New Fortress Energy LLC was held on the 14th of January, and the market cleared the risk at 26.625%, which was marginally higher than the pre-auction price level on the deliverable bonds at 25.625%. The original default on New Fortress Energy LLC was triggered on a Failure-To-Pay credit event on 20 November, and the name formed part of CDX High Yield Series 43-45, so it was a recent addition to highly tradable credit indices.

During the period, the fund (A-class) "lost" some 0.44% over the month, underperforming the benchmark by 0.72%. The underperformance was primarily as a result of an administrative error regarding a coupon on one of the fund assets which is currently under investigation. We are expecting the fund to recoup around 0.68% upon the correction.

**Glossary**

**Annualised Performance:** Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

**Highest & Lowest Performance:** The highest and lowest performance for any 1 year over the period since inception have been shown.

**NAV:** The net asset value represents the assets of a Fund less its liabilities.

**Current Yield:** Annual income (interest or dividends) divided by the current price of the security.

**Alpha:** Denotes the outperformance of the fund over the benchmark.

**Sharpe Ratio:** The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

**Sortino Ratio:** A measure of the risk-adjusted return of a portfolio. It is a modification of the Sharpe ratio but only penalises the returns falling below a user specified target, or required rate of return, while the Sharpe ratio penalises both upside and downside volatility equally.

**Standard Deviation:** The deviation of the return stream relative to its own average.

**Max Drawdown:** The maximum peak to trough loss suffered by the Fund since inception.

**Max Gain:** Largest increase in any single month.

**% Positive Month:** The percentage of months since inception where the Fund has delivered positive return.

**Default Risk:** The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
