







QUARTERLY INVESTMENT REPORT - Q4 2024

The Long Beach Worldwide Flexible Prescient Fund experienced a positive fourth quarter to finish the year with an encouraging outperformance vs. the benchmark, ASISA Worldwide Multi Asset Flexible Sector Average, re-establishing the fund's long-term performance track record. The fund returned 27.6% for calendar 2024 vs. 14.3% for the benchmark. The fund's annualised return since inception is 13.8% vs. 11.1% for the benchmark.

Richemont

Richemont reported a robust performance for the third quarter ended 31 December 2024, with sales increasing by 10% at constant and actual exchange rates. The company achieved its highest-ever quarterly sales of €6.2 billion, driven by double-digit growth in the Americas, Europe, Middle East & Africa, and Japan. This was despite a 7% decline in Asia Pacific sales, primarily due to an 18% decline in Mainland China, while other Asian markets showed improvement. Sales increased 19% in Europe and 22% in the Americas.

Key highlights included:

- Jewellery Maison's: Sales grew by 14%, reflecting strong demand for high-end jewellery.
- **Specialist Watchmakers:** Sales grew across all regions except Asia Pacific, with notable double-digit increases in the Americas and Middle East & Africa, moderating from a 16% decline in the first half of the year to an 8% decline in Q3.
- Retail Channel: Retail sales increased by 11%, showcasing the strength of Richemont's direct-to-consumer strategy.

Richemont has a robust balance sheet with a €7.9bn net cash position, and solid ongoing cash flow. Richemont reported net operating cash flow of €3.2 billion for the fiscal year ending March 2024. This strong cash flow generation reflects Richemont's efficient operations and effective working capital management. Richemont's strong cash flow and solid balance sheet provide a stable foundation for future growth and strategic investments, together with the potential to increase dividends to shareholders.

Impact of Trump's Win on US Equity and Bond Markets

Donald Trump's victory in the 2024 US presidential election had a significant impact on the US equity and bond markets. The immediate market reaction was a sharp rise in US stocks, bond yields, and the US dollar

Equity Markets: US stocks surged following Trump's win, driven by investor optimism around potential tax cuts, deregulation, and increased infrastructure spending. In his first term Trump proved to be a prolific spender, including through tax cuts, and government spending ultimately shows up in corporate profits.

Bond Markets: Bond yields rose sharply as investors anticipated higher inflation and increased government borrowing to fund Trump's proposed policies. This led to a sell-off in bonds, pushing yields higher.

Inflation Developments in the US and the Fed's Response

The US Consumer Price Index (CPI) rose by 2.9% year-over-year in December 2024, up from 2.7% in November. Core CPI, which excludes food and energy prices, increased by 3.2% year-over-year, slightly down from 3.3% in November.

The Federal Reserve cut interest rates three times in 2024, with a 25bp cut in December following on from a 25bp cut in November, and an initial 50bp cut in September. While there is potential for the Fed to cut rates again in 2025 if inflation continues to moderate, the ongoing strength of the US economy and labour market is likely to keep the Fed cautious.

The January 2025 US Non-Farm Payroll report showed a strong labour market, with total nonfarm payroll employment increasing by 256,000 jobs. The unemployment rate remained steady at 4.1%, indicating a stable job market. Key sectors contributing to job growth included healthcare, government, and social assistance.

Conclusion

The Long Beach Worldwide Flexible Prescient Fund's diverse portfolio, including strong performers like Richemont, positions it well for continued growth. The fund is fully invested in global equities and ETFs which offer attractive growth potential. The companies in which the fund is invested are benefitting from structural growth trends including luxury goods, digital commerce and payments, on-demand mobility, travel and remote work, cloud computing and AI, cyber security, digital advertising and medical devices.

The fund has adhered to its policy objective, and the fund's asset allocation is broadly similar to 30 September 2024.
