Investment policy

The objective of this fund is to generate long-term capital growth and outperform the benchmark over a rolling five year period. The fund will have exposure to a broad range of markets across multiple asset classes, including both local and offshore investments. Underlying investments may include both actively managed and index-tracking strategies. The strategy is constructed with a medium allocation to equity.

The fund has adhered to its policy objectives as stated in the supplemental deed.



Portfolio composition

The Cogence Balanced Prescient Fund of Funds is constructed as a diversified portfolio of funds spanning various asset classes, and across both active and passive strategies. Asset allocation and global manager selection advice is provided by BlackRock, while RisCura provide local manager selection.

During the fourth quarter of 2024, the portfolio's offshore (global ex-SA) allocation remained unchanged at 37,30%. SA cash and SA equity reference allocations were reduced by 1.30% and 1.00%, respectively, and redeployed into SA bonds. The local and global managers remained unchanged.

The portfolio remains within the defined risk parameters of a high risk profile as per the ASISA category's maximum equity allowance of up to 75%

Monthly market commentary

Despite some volatility, markets performed positively with developed equity gaining 3.53% over the month while global fixed income gained 0.39%, both in USD terms. Unlike last year, European equities were the strongest performers while US equities lagged as inflation fears decreased expectations for rate cuts this year while the release of DeepSeek's AI model highlighted concerns about valuations in the US tech sector. Local markets performed broadly in line with global markets in ZAR terms. Within fixed income, markets generally saw yields rising across Europe, while the US 10-year fell from 4.57% to 4.55% and the 2-year decreased from 4.24% to 4.20%. The Federal Reserve took a cautious stance and maintained the target range for the federal funds rate at 4.25-4.5%. The European Central Bank lowered their key rates by 25bps, bringing the deposit facility rate to 2.75%.

South African equities delivered positive returns in January lead by the resources sector as gold benefitted from an increase in geo-political uncertainty. Expectations for economic growth improved in the month with Bloomberg consensus (January) forecasting South Africa's economic growth to reach 1.7% in 2025 as a result of improved infrastructure and agricultural performance. The South African Reserve Bank (SARB) continued to cut rates, delivering a 25bp rate cut in January which was largely in line with market expectations. However, accompanying statements were relatively hawkish, highlighting the potential impact of tariffs and uncertainty of inflation path. Broad guidance is still towards a neutral stance which has been indicated as ~50bps away. Finally, the Rand strengthened against USD in January, despite a volatile environment, closing at around R18.66/\$ compared to R18.90 /\$ in December.

Yields

The yield for bond and income portfolios is historic and is calculated quarterly.

Important information

The collective investment scheme may borrow up to 10% of the market value of the portfolio to bridge insufficient liquidity. Lump-sum performance returns are being quoted. Income distributions, prior to deduction of applicable taxes, are included in the performance calculations. NAV to NAV figures have been used for the performance calculations, as calculated by the manager at the valuation time of 16:00 as defined in the deed, over all reporting periods. Investment performance calculations are available for verification upon request by any person. Reinvestment of income is calculated on the actual amount distributed per participatory interest, using the ex-dividend date NAV price of the applicable class of the portfolio, irrespective of the actual reinvestment date. The performance is calculated for the fee class. The individual investor performance may differ, as a result of initial fees, the actual investment date, the date of reinvestment and dividend withholding tax.

The rate of return is calculated on a total return basis, and the following elements may involve a reduction of the investor's capital: interest rates, economic outlook, inflation, deflation, economic and political shocks or changes in economic policy. Annualised returns are period returns re-scaled to a period of one year. This allows investors to compare returns of different assets that they have owned for different lengths of time. All period returns greater than one year have been annualised. Returns for periods less than one year have not been annualised. A cumulative return is the aggregate amount an investment has gained or lost over time, independent of the period of time involved. Actual annual figures are available to the investor on request. Glossary

 ${\it Annualised\ return} \ {\it -} \ {\it An\ annualised\ return} \ is \ the \ weighted \ average\ compound\ growth \ rate\ over the\ period\ measured.}$

 ${\it Highest \& Lowest \ return -} \ {\it The highest and lowest \ returns for any one year over the period since inception have been shown.}$

Volatility - Volatility (also called standard deviation) is a measure of how widely the returns varied over the period measured.

Maximum drawdown - A maximum drawdown is the maximum loss from a peak to trough of the portfolio over the period measured, before a new peak is attained.

Sharpe ratio - The sharpe ratio is a measure of risk-adjusted returns. The sharpe ratio reflectes the extent to which an investment compensates for extra risk.

NAV - The net asset value represents the assets of a fund less its liabilities.

What is the total investment charge (TIC)

Total expense ratio (TER) is the percentage of the value of the portfolio that was incurred as expenses relating to the administration (charges, levies and fees) of the portfolio. TER is calculated over rolling 3 years (or since inception, where applicable), and is annualised, to the most recent calendar quarter-end. A higher TER does not necessarily imply a good return. The current TER may not necessarily be an accurate indication of future TER's. Transaction costs (TC) is the percentage of the value of the portfolio that was incurred as costs relating to the buying and selling of the assets underlying the portfolio. Transaction Costs are a necessary cost in administering the portfolio and impacts portfolio returns. It should not be considered in isolation, as returns may be impacted by many other factors over time, including market returns, the type of financial product, the investment decisions of the investment manager, and the TER. Calculations are based on actual data, where possible, and best estimates, where actual data is not available. Total investment charges (TIC) is the percentage of the value of the portfolio that was incurred as costs relating to the investment of the portfolio. It is the sum of the TER and TC.
