

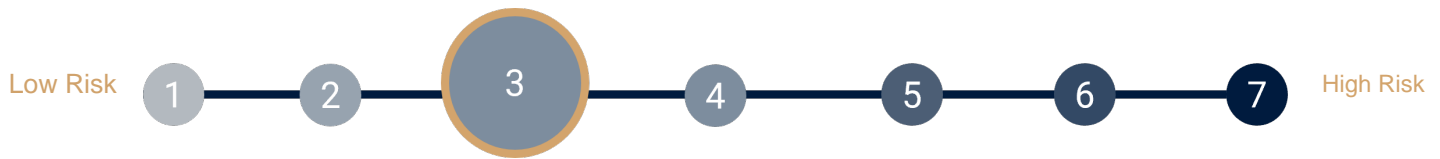
Strategy

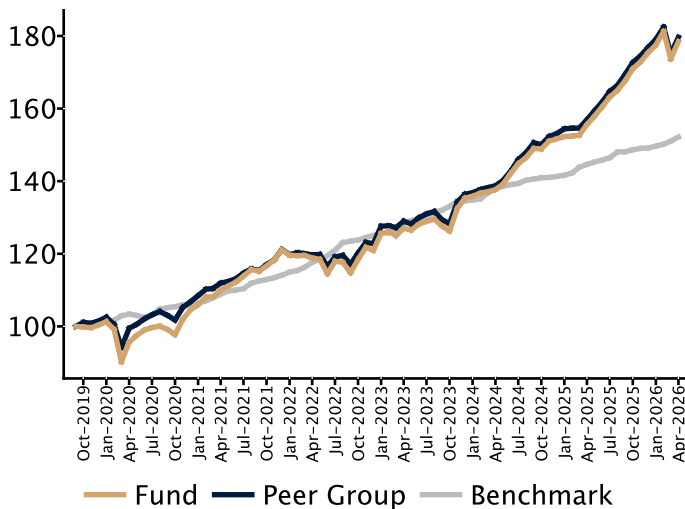
