/ Portfolio description

The primary objective of the portfolio is to achieve long term capital appreciation by investing in a diversified portfolio of **South African listed equities**. The portfolio manager acquires local equities at levels below the assessment of the companies' fair values. The portfolio manager also takes cognisance of worldwide economic, sector and investment trends to tilt the portfolio towards attractive sectors and companies.

The Integrity Equity Prescient Fund is required to invest a minimum of 80% of the portfolio in equities and is therefore suitable for investors with an investment horizon of five years or longer.

Integrity diligently follows a **value investment philosophy and process**. This is the same investment philosophy and process applied in managing the Integrity Local Equity Strategy, with track record since 5 August 2011.

The portfolio has adhered to its policy objective since its inception.





/ Sector allocation



/ Relative performance

Over the quarter, the Fund generated a return of 8.60% compared to the FTSE/JSE All Share Index's total return of 8.10%. The Fund benefitted from its top performing shares over the period, namely; ABSA, Astoria, KAP and Nedbank. Additionally, the Fund benefitted from its material underweight to the Naspers/Prosus stable. Conversely, the largest detractors of performance relative to the benchmark was the lack of exposure to FirstRand, Standard Bank and Capitec which detracted 2.74% of alpha over the period. This was partially mitigated by the Fund's allocation to the Satrix FINI ETF. Furthermore, the Fund's underweighting to MTN and platinum group metals producers (Impala Platinum, Sibanye Stillwater and Valterra) and overweighting to TFG hurt its performance during the quarter. Lastly, the recovery in certain industrial holdings, namely: Reunert, Oceana, Aspen and Hudaco contributed materially to the Fund's performance. Over the quarter, value outperformed growth, as the FTSE/JSE Growth Total Return Index increased by 3.47% compared to an increase of 13.58% in the FTSE/JSE Value Total Return Index. Considering the current macro backdrop, the Investment Manager expects value to continue outperforming growth in the future once fundamentals regain focus.

/ Fund composition

Over the quarter, the Investment Manager decreased exposure to counters that performed well, namely; Anglo American, AngloGold Ashanti, Prosus, and the Satrix FINI ETF. Additionally, the Fund's exposure to Adcock Ingram was removed when Natco acquired and took the company private. Exposure to Astoria was also removed after the Fund accepted Astoria's repurchase, delisting and Goldrush unbundling plan. The Investment Manager increased exposure to Truworths, TFG, Nedbank, Aspen, SPAR, Reunert and KAP. Additionally, the Investment Manager initiated exposure to Mondi, AECI, and Bidvest and received the unbundled Goldrush shares during the quarter. The above portfolio changes resulted in a slight decrease in cash exposure from 15.56% to 14.24%. The Resources allocation marginally decreased from 17.41% to 16.91%, Industrials allocation increased from 47.23% to 49.36%, and the Financials allocation decreased from 19.80% to 19.49%.

/ Glossary

Annualised performance: Annualised performance shows longer-term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest return: The highest and lowest returns for any 1 year over the period since inception have been shown.

NAV: The Net Asset Value represents the assets of a Fund less its liabilities.

Risk profile: A measure of the volatility of the fund and volatility is a statistical measure of the dispersion of returns for a given security. Low risk portfolios indicates less volatility with potentially lower returns and high risk portfolios indicates more volatility with potentially higher returns. High risk portfolios generally hold more equity exposure than any other risk portfolios and therefore tend to carry higher volatility.

/ Risk

Liquidity risk: If there are insufficient buyers or sellers of particular investments, the result may lead to delays in trading and being able to make settlements, and/or large fluctuations in value. This may lead to larger financial losses than expected.
