INVESTMENT AND RETURN OBJECTIVE

The Fund aims to achieve significant real returns over the long term and to outperform the ASISA category average of the South African - Multi-Asset - High Equity funds over a full market cycle by maintaining meaningful exposure to growth assets like equities.

INVESTMENT PROCESS

The Fund invests across a range of assets including equities and interest bearing instruments, both domestically and offshore. The asset allocation is anchored at the long-term strategic allocation, but can be varied tactically to target outperformance of the benchmark by capitalising on signals of significant market mispricing. Where possible, a process of enhanced indexation is utilised within asset classes to deliver stable incremental alpha.

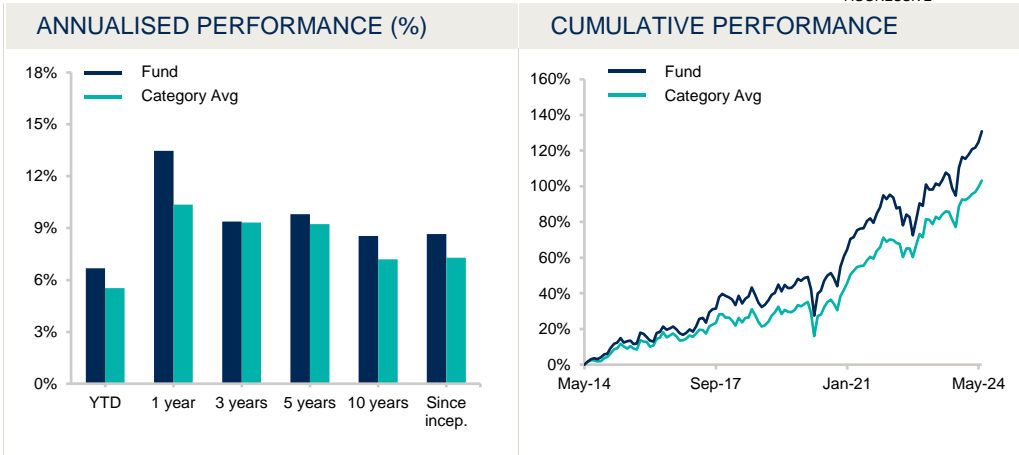
WHO SHOULD INVEST

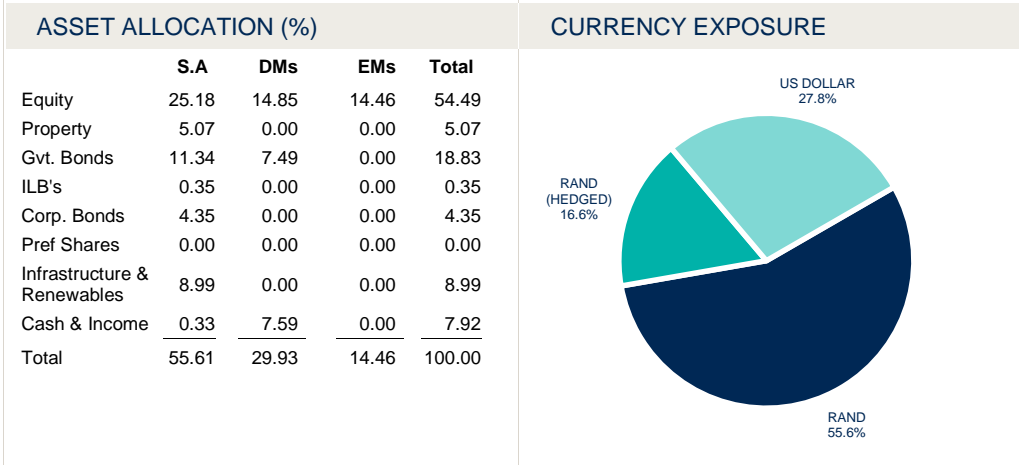
RISK INDICATOR DEFINITION

FUND COMMENTARY

Over the course of June, US Treasuries gained 1% as the Federal Reserve held interest rates steady at their current range of 5.25% to 5.5%, but revised its outlook for rate cuts to just one in 2024. Federal Reserve Chair Jerome Powell described recent inflation readings as promising steps in the right direction but said that policymakers need to be more certain of the sustainability of that trend before lowering interest rates. The European Central Bank (ECB) cut interest rates for the first time since 2019 last month, bringing central bank's key rate to 3.75%, down from a record 4% where it had been since September 2023. The market is currently pricing in at least one more cut before the end of the year. Meanwhile, the Bank of England kept interest rates unchanged at a 16-year high of 5.25%, a move that had been widely expected. The Bloomberg Global Aggregate Index, a measure of global investment-grade debt from multiple local currency markets, ended marginally higher. French bonds were under pressure following the uncertainty around the elections. The spread between the 10-year French and German bonds widened by more than 30 basis points (bps) to 80 bps.

European indices ended over 1% lower, with France's CAC 40 plunging 6.2% after French President Emmanuel Macron announced he would dissolve parliament and call for new elections following a heavy defeat in the EU elections. The announcement came after exit polls indicated that Marine Le Pen's National Rally was set to win around 31.5% of the vote, compared to 14.5% for Macron's Renaissance party.

The UK is set to hold its elections this month, with polls suggesting the centre-left Labour Party will come into power. This would put Britain on the brink of massive change, marking the end of Conservative Party leadership, which has been in power since 2010.

South African asset prices enjoyed a fierce rally in June, as the two leading political parties, the African National Congress (ANC) and the Democratic Alliance (DA), along with other smaller parties, agreed to form a Government of National Unity (GNU). This outcome was seen as more market-friendly, significantly reducing the risk premium associated with investing in South Africa. The 5-year CDS spread, expressed in basis points, which is essentially a premium paid by the buyer to the seller of a Credit Default Swap to insure against default, fell by 32 bps to 209 bps.

Global equities showed mixed performance in June. In the US, the S&P 500 jumped 3.6%, led by a tech rally, with the Nasdaq surging 6%. However, the S&P 500 ex-tech fell by 0.5%. Moving eastward, the Shanghai Composite Index dropped by 3.9%, while Hong Kong's Hang Seng Index erased gains from May, dropping 2.3%. Commodity prices cooled after a 3-month rally. The Bloomberg Commodity Index slipped 1.9% to end the quarter. The local equity benchmark, the All Share Total Return Index, jumped 4.1%, with the financial sector leading the pack with a strong performance of 14.5%. Only two sectors posted negative returns: technology and basic materials. The All Bond Index (ALBI) returned 5.24% in June. The USDZAR exchange rate strengthened by 3.2%, ending the month at 18.19.

Contributors to performance:

Local Equity was the strongest contributor to performance over the month.

Detractors from performance:

The strengthening rand was the largest detractor to performance.

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Fund Specific Risks

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

Derivatives risk: The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.
