

INVESTMENT OBJECTIVE

The Fund will aim to deliver a high real income stream over the target period and to wind-up or be re-purposed at the end of the target period.

INVESTMENT POLICY

The Fund will aim to deliver real income for investors with an investment time horizon until 2040. In order to achieve this objective, the fund will apart from assets in liquid form, invest primarily in inflation-linked bonds with target maturity dates between 2035-2040, money market instruments and NCDs.

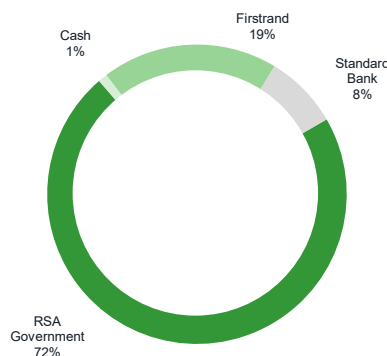

FUND COMMENTARY

The SA Government 10-year yield has held up well relative to the weakness in US 10-yr Treasuries, finishing the year at 9.03%. Against the backdrop of more moderate inflation, a recent upgrade by S&P Global Ratings, the stabilisation of the country's politics and electricity supply, and a more positive growth outlook, the real yield currently on offer (almost 6%) is attractive for local and foreign buyers, despite the country's volatile exchange rate.

SA's risk premium has narrowed by more than 220 bp in less than a year. A sustainable drop in our long bond yield from +10% to 9% or lower is a welcome fillip to our country's finances. SA could lower this even more by improving governance and closing the inflation differential to 1%. This would boost local bond prices and lower our budget deficit, our debt trajectory and our cost of capital.

General Information

Collective Investment Schemes in Securities (CIS) should be considered as medium to long-term investments. Forward pricing is used.

Total Expense Ratio (TER)

The Fund's **Total Expense Ratio (TER)** reflects the percentage of the average **Net Asset Value (NAV)** of the portfolio that was incurred as charges, levies and fees related to the management of the portfolio. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER cannot be regarded as an indication of future TER's. During the phase in period TER's do not include information gathered over a full year.

Transaction Costs (TC)

Transaction Costs (TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER.

Total Investment Charge (TIC)

The sum of the TER and TC. The accurate figures will be available a year after the fund's inception date.

Glossary Summary

Performance: Performance has been calculated using NAV to NAV with income reinvested.

Moderately Conservative: This portfolio can invest across the duration spectrum from money market to long bonds, which can result in capital volatility over the shorter term and deviation from the benchmark.

Fund Specific Risk

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

Derivatives Risk: The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.

Interest Rate Risk: The value of fixed income investments (e.g. bonds) tends to be inversely related to interest and inflation rates. Hence their value decreases when interest rates and/or inflation rises.
