The Fund will aim to deliver higher levels of income compared to money market funds.

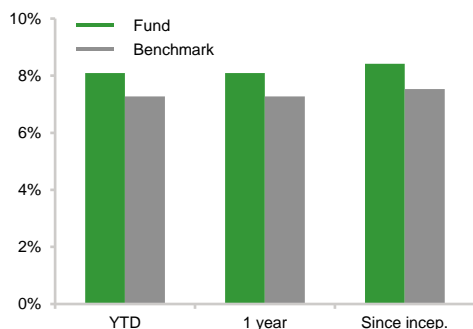
INVESTMENT POLICY

RISK INDICATOR

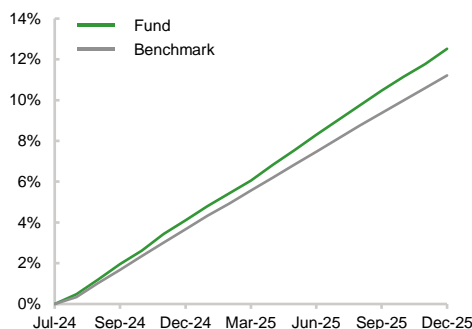


ANNUALIZED PERFORMANCE (%)

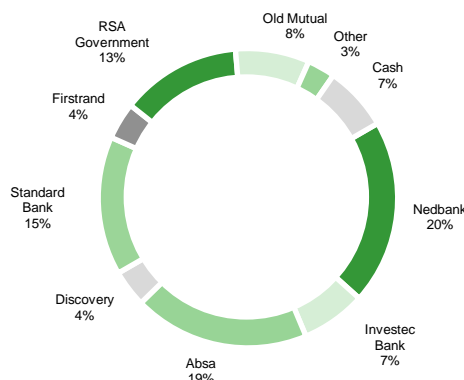

FUND COMMENTARY

Bond prices have gradually strengthened since April, as the angst over America's anti-SA rhetoric and tariff threats subsided and the GNU survived the budget bill disputes. Since breaking above 11% in the wake of "Liberation Day" in April, the 10-year yield has eased down to 8.2%, a remarkable recovery. A series of positive developments have attracted buyers, local and offshore. 1) A turnaround in SA's state finances: the primary budget surplus is expected to reach 2.5% of GDP by 2028/29 and stabilize the debt-to-GDP ratio at 78%. 2) Ratings upgrade: S&P Global lifted SA's long-term foreign currency rating to BB-, this aligns with the rating from Moody's and moves us just two notches below investment grade. 3) Low and stable inflation: core inflation has been around 3% for the last nine months already. 4) The country's electricity supply has stabilized. 5) SA has been removed from the FATF grey list. 6) The rise in precious metal prices, coupled with the ongoing weakness in the oil price has greatly improved SA's terms of trade. 7) The currency has strengthened and rand-dollar volatility has declined.

Risk Indicator Definition

These portfolios typically have no or low equity exposure, resulting in higher interest yields and stable capital values with the probability of capital losses over the shorter term (3 months) highly unlikely. These portfolios typically target returns in the region of 1% – 3% above inflation before tax over the long term.

The portfolio has adhered to its objective and there were no material changes to the composition of the Fund portfolio during the quarter.

Glossary

Annualised Performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest Performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Total Expense Ratio (TER%): The Total Expense Ratio (TER) is the percentage of the net asset value of the class of the Financial Product incurred as expenses relating to the administration of the Financial Product.

Transaction Costs (TC%): The Transaction Costs (TC) is the percentage of the net asset value of the Financial Product incurred as costs relating to the buying and selling of the assets underlying the Financial Product.

Total Investment Charges TIC (%) = TER (%) + TC (%): The Total Investment Charges (TIC), the TER + the TC, is the percentage of the net asset value of the class of the Financial Product incurred as costs relating to the investment of the Financial Product. It should be noted that a TIC is the sum of two calculated ratios (TER+TC).
