Investment policy

The objective of this fund is to generate long-term capital growth and outperform the benchmark over a rolling five year period. The fund will have exposure to a broad range of markets across multiple asset classes, including both local and offshore investments. Underlying investments may include both actively managed and index-tracking strategies. The strategy is constructed with a medium allocation to equity.

The fund has adhered to its policy objectives as stated in the supplemental deed.



Portfolio composition

The Cogence Balanced Prescient Fund of Funds is constructed as a diversified portfolio of funds spanning various asset classes, and across both active and passive strategies. Asset allocation and global manager selection advice is provided by BlackRock, while RisCura provide local manager selection.

There have been no material changes to the composition of the fund over the last quarter.

The portfolio remains within the defined risk parameters of a high risk profile as per the ASISA category's maximum equity allowance of up to 75%

Monthly market commentary

September was a challenging period for global equity and global fixed income markets, consequently we saw global assets underperforming their local counterparts this month. Global markets saw a significant risk-off move at the start of the month, and with the recent macro environment, the Fed delivered a 50bps rate cut and the ECB delivered a 50bps rate cut at their September meetings. The favourable rate cuts and positive momentum in China, following the People's Bank of China announcement of a large stimulus package, helped contribute to global equity and the bond market experienced a steepening in the yield curve. Global markets finished the month positively with developed equity gaining 1.83% over the month while global fixed income gained 1.16%, both in USD terms. However, local markets outperformed their global counterparts with local equity gaining 3.91% and local bonds gaining 3.89% in ZAR terms. South African equity benefitted this month off the back of exposure to the China economy where we saw MSCI China Index gain 23% in September. China's stimulus announcement could be particularly favourable for South Africa's commodity-driven sector, if China's growth is sustainable, it could benefit commodity prices. South African bonds benefitted this month from the US dollar weakening against the ZAR and a local driver of outperformance was the South African Reserve Bank (SARB) cutting the repo rate by 25bps to 8% in September.

Similarly to developed central banks, investors are pricing in the SARB entering a mild rates cutting cycle. Separately, the sustained lack of load shedding this year continues to benefit the South African economy with the September manufacturing PMIs climbing to 51 from 50.5 in August. The strengthening economy is also characterised by improved consumer confidence and inflation falling to 4.4% compared to 4.6% the previous month. Finally, the Rand strengthened against USD in September closing at around R17.282/\$ compared to R17.834/\$ in August.

Yields

The collective investment scheme may borrow up to 10% of the market value of the portfolio to bridge insufficient liquidity. Lump-sum performance returns are being quoted. Income distributions, prior to deduction of applicable taxes, are included in the performance calculations. NAV to NAV figures have been used for the performance calculations, as calculated by the manager at the valuation time of 16:00 as defined in the deed, over all reporting periods. Investment performance calculations are available for verification upon request by any person. Reinvestment of income is calculated on the actual amount distributed per participatory interest, using the ex-dividend date NAV price of the applicable class of the portfolio, irrespective of the actual reinvestment date. The performance is calculated for the fee class. The individual investor performance may differ, as a result of initial fees, the actual investment date, the date of reinvestment and dividend withholding tax.

The rate of return is calculated on a total return basis, and the following elements may involve a reduction of the investor's capital: interest rates, economic outlook, inflation, deflation, economic and political shocks or changes in economic policy. Annualised returns are period returns re-scaled to a period of one year. This allows investors to compare returns of different assets that they have owned for different lengths of time. All period returns greater than one year have been annualised. Returns for periods less than one year have not been annualised. A cumulative return is the aggregate amount an investment has gained or lost over time, independent of the period of time involved. Actual annual figures are available to the investor on request. Glossary

Annualised - An annualised return is the weighted average compound growth rate over the period measured.

Volatility - Volatility (also called standard deviation) is a measure of how widely the returns varied over the period measured.

Maximum drawdown - A maximum drawdown is the maximum loss from a peak to trough of the portfolio over the period measured, before a new peak is attained.

Sharpe ratio - The sharpe ratio is a measure of risk-adjusted returns. The sharpe ratio reflectes the extent to which an investment compensates for extra risk.

What is the total investment charge (TIC)

Total expense ratio (TER) is the percentage of the value of the portfolio that was incurred as expenses relating to the administration (charges, levies and fees) of the portfolio. TER is calculated over rolling 3 years (or since inception, where applicable), and is annualised, to the most recent calendar quarter-end. A higher TER does not necessarily imply a good return. The current TER may not necessarily be an accurate indication of future TER's. Transaction costs (TC) is the percentage of the value of the portfolio that was incurred as costs relating to the buying and selling of the assets underlying the portfolio. Transaction Costs are a necessary cost in administering the portfolio and impacts portfolio returns. It should not be considered in isolation, as returns may be impacted by many other factors over time, including market returns, the type of financial product, the investment decisions of the investment manager, and the TER. Calculations are based on actual data, where possible, and best estimates, where actual data is not available. Total investment charges (TIC) is the percentage of the value of the portfolio that was incurred as costs relating to the investment of the portfolio. It is the sum of the TER and TC.
