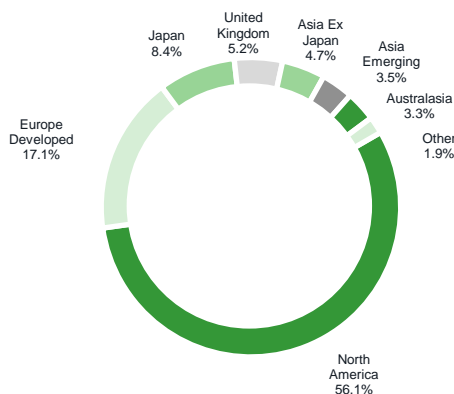

FUND COMMENTARY

After all the mixed messages of the past few months, the evidence is now tilted towards weaker second half growth. Still, a soft landing remains the most likely outcome. The US economy continues to expand at a good pace, the momentum in China is slowing but still positive, and Japan's recovery ongoing. The big laggard is Europe, where both the UK and Eurozone are stagnating. The US Fed cut its benchmark rate by 50bp, to 4.75 – 5.00% in September. It is the Fed's first easing in four years. Despite record-high interest rates, the US is motoring along. Headline inflation is nearing the policy target, but core inflation has stalled at 3% and services inflation is stuck above 4%. The central banks in Europe have a greater urgency to lower rates, given their struggling economies, but the lingering strength of services inflation means they are likely to ease more gradually. September was a prime example of the market's see-saw as to whether the U.S. economy would dodge a recession and also allow interest rates to come down. That is the ideal scenario for investors, and the base case that has propelled the S&P500 to numerous new highs in 2024. But any data to the contrary – signs that the economy is slowing, or that inflation is not moderating enough to allow rate cuts – results in pull-backs.

Risk Indicator Definition

Generally, these portfolios hold more equity exposure than any other risk profiled portfolio therefore tend to carry higher volatility. Expected potential long-term returns could be higher than other risk profiles, in turn potential losses of capital could be higher.

Glossary

Highest & Lowest Performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Total Expense Ratio (TER%): The Total Expense Ratio (TER) is the percentage of the net asset value of the class of the Financial Product incurred as expenses relating to the administration of the Financial Product.

Transaction Costs (TC%): The Transaction Costs (TC) is the percentage of the net asset value of the Financial Product incurred as costs relating to the buying and selling of the assets underlying the Financial Product.

Total Investment Charges TIC (%) = TER (%) + TC (%): The Total Investment Charges (TIC), the TER + the TC, is the percentage of the net asset value of the class of the Financial Product incurred as costs relating to the investment of the Financial Product. It should be noted that a TIC is the sum of two calculated ratios (TER+TC).
