FUND UNIVERSE

The portfolio can have a maximum effective equity exposure (including international equity) of up to 75% and a maximum effective property exposure (including international property) of up to 25% of the market value of the portfolio. The portfolio is permitted to invest in listed and unlisted financial instruments in line with the conditions as determined by legislation from time to time.



This is a minimum disclosure document. Collective Investment Schemes in Securities (CIS) should be considered as medium to long-term investments.
